Herein the women from other states were provisionally allowed to write Mains UKPCS as they got the marks above the cut off but were denied the 30% reservation and instead was allowed to only Women who were having Uttarakhand domicile which we challenged. Consequently, stay was granted and was held that they were violative of Fundamental Rights and Constitutionally invalid.

I have completed BA LLb(5yrs. Course) from Nagpur University. I am enrolled in the Bar Council of Delhi in the year 2016 vide registration D/3533/2016.
