PROCEEDINGS OF SITTING HELD ON 06.03.2018 AT 12.00 NOON CHAIRED BY SHRI NAND KUMAR SAI, HON'BLE CHAIRPERSON, NATIONAL COMMISSIN FOR SCHEDULED TRIBES (NCST) ON THE REPRESENTATION OF SHRI VIJAY DEVRAM BURDE, VILLAGE & POST – KHARADI, TALUKA – SANGAMNER, DISTRICT - AHMEDNAGAR (MAHARASHTRA) REGARDING ENCROACHMENT OF LAND OF SCHEDULED TRIBES.

Date of Sitting: 06.03.2018

Representation received from Shri Vijay Devram Burde, Village & Post – Kharadi, Taluka – Sangamner, District - Ahmednagar (Maharashtra) regarding encroachment of land of Scheduled Tribes.

2. The Sitting was held on 26.05.2015 under the Chairmanship of Dr. Rameshwar Oraon, Hon'ble Chairperson, NCST with Sub-Divisional Magistrate(SDM), Sangamner, District Ahmednagar and Nayab Tehsildar, Sangamner, Ahmednagar and Shri Vijay Devram Burde (Petitioner) to discuss the matter. In the Sitting, SDM, Sangamner sought 2 months time for enquiry in the matter. Time was allowed by the then Hon'ble Chairperson.

3. The Office of Collector, Ahmednagar vide letter No. Scy.Dsk.119/214/2016 dated 18.05.2016, letter No. kuka/kaksha 10 D/850/2016 dated 15.10.2016 and letter No. Revenue Office/land/2A/890/2017 dated 24.07.2017 had furnished the facts in the matter. These letters were referred to Shri Vijay Devram Burde for information and satisfaction. Shri Burde vide rejoinder dated 12.12.2017 had refuted the facts furnished by the O/o Collector, Ahmednagar and requested for justice. This rejoinder was sent to District Collector, Ahmednagar for furnishing the facts in the matter within 30 days from receipt of the letter for placing before the Hon'ble Chairperson, vide NCST letter No. VDB/2/2015/STGMH/DEOTH/RU-IV dated 12.12.2017.

4. The information was not received from the Collector, District Ahmednagar. Accordingly, Hon'ble Chairperson decided a Sitting should be fixed for 06.03.2018 to discuss the issue with the Principal Secretary, Revenue Department, Govt. of Maharashtra and the Collector and District Magistrate, District Ahmednagar.

5. The Principal Secretary, Revenue Department, Govt. of Maharashtra, Mumbai was appeared in person before the Hon'ble Chairperson and Collector, District Ahmednagar deputed Additional Collector, District Ahmednagar for attending the Sitting.

6. Hon'ble Chairperson asked Shri Vijay Devram Burde to explain his grievance. Shri Burde explained that his land has been occupied by the non-ST and requested for justice at the earliest since this matter is lying with the Commission from March, 2015.

7. The Hon'ble Chairperson asked the Principal Secretary, Revenue Department, Govt. of Maharashtra and Additional Collector, Ahmednagar to explain the facts in the matter. Principal Secretary, Revenue Department asked Additional Collector, Ahmednagar throw the facts on the issues in detail. Additional Collector informed that the said land was allotted in the name of his (petitioner) father. The said land had been sold by his mother and brother, but said land has not been transferred in the name of purchaser so far. This land could be transferred in his name by adopting some formal procedure.

8. Hon'ble Chairperson asked the Additional Collector, in this process, how much time will be required. The Additional Collector told that at-least 3 months time will be required.

9. Hon'ble Chairperson recommended that the case will be settled within 3 months from receipt of the proceedings of the Sitting and action taken report may also be communicated to the Commission in the matter.
