




This case was discussed with the Panchyat Rural Housing and Rural Development Department, (PRHRD Department) Govt. of Gujarat and the petitioner in the sitting held on 06/06/2017 at NCST, New Delhi under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST. This issue was again discussed in the sitting held on 04/10/2017 at NCST with Principal Secretary, PRHRD Department, Govt. of Gujarat and the Deputy Collector, Narmada. Further, Shri H. C. Vasava, Hon'ble Member, NCST on 02/04/2018 to 04/04/2018 visited the State of Gujarat and discussed this case with the Govt. of Gujarat Officers. The Tour Report was forwarded to the PRHRD Department, Govt. of Gujarat vide NCST letter dated 24/04/2018. The Principal Secretary, PRHRD Department, Govt. of Gujarat vide letter No. ARJ-102008-2332-D dated 12/04/2018 had conveyed that "such appointments on compassionate ground as a special case lie under the purview of Hon'ble Chief Minister".

The Hon'ble Member fixed the sitting on 07/06/2018 at Lok Nayak Bhawan, New Delhi with the Principal Secretary, PRHRD Department, Additional Chief Secretary, General Administration, Govt. of Gujarat, the Collector, District Narmada and petitioner. The petitioner and Collector, Narmada District was absent. The Deputy Secretary, PRHRD Department and Deputy Secretary, General Administration Department, Govt. of Gujarat were appeared before the Commission. The PRHRD Department vide letter No. ARJ-102007-2332-(Chh) D dated 29/05/2018 had conveyed that the case of Shri Kiranbhai Chhotubhai Vasava was forwarded to the Govt. of Gujarat through General Administration Department as a special case. The Govt. has declined to accept the application of Shri Kiranbhai Chhotubhai Vasava.

The Hon'ble Member asked the representative of the State Govt. of Gujarat Officials to suggest how to help the petitioner, who is very poor and facing the financial crunch for livelihood. The case of Shri Kiranbhai Chhotubhai Vasava not examined by the Department in the right time. Therefore, he is facing a lot of problems for his livelihood. Representatives explained the action taken by the Department and told that only Hon'ble Chief Minister is empowered to re-consider the case.

If it is not possible, then Shri Kiranbhai Chhotubhai Vasava case be considered on the new rule / policy adopted by the Govt. of Gujarat for the cases of compassionate ground and provide the financial benefits.
