Representation dated nil received from Ms. Meenaben, D/o Seliben Ratanbhai Vasava, R/o Bhacharwada, Tehsil - Nandod, District - Narmada, Gujarat regarding land grabbed illegally by Shri Kaushik Somabhai Patel.

The NCST vide communication dated 12/03/2018 referred the matter to Secretary, Revenue Department, Govt. of Gujarat and Collector, District – Narmada for furnishing the facts and action taken report in the matter within 30 days for examination by the Commission. Action Taken Report and facts in the matter had not been received from these authorities.

The Hon'ble Member, Shri H. C. Vasava fixed the sitting on 30/07/2018 at Circuit House, Gandhinagar to discuss the issue with the Additional Chief Secretary, Revenue Department and Collector, District - Narmada. In the sitting, Collector, District - Narmada and Deputy Secretary, Revenue Department were present. The petitioner was absent.

The Hon'ble Member asked the Collector, District - Narmada to explain the action taken by them in the matter. The Collector, District Narmada informed that matter relates with the District Panchayat authorities of Narmada District but not submitted any report / action taken by them.

After discussion, it was recommended / suggested that the District Collector, District - Narmada should submit a report on the representation of Ms. Meenaben to the Commission within 15 days from the date of sitting. After receipt of the report from Collector, District -- Narmada, further course of action will be decided by the Commission.
