Representation dated 16/03/2018 received from Shri Vinodbhai Luxibhai Lotda, Primary School, Karchond, Payaripada, Dudhani Centre, Dadra & Nagar Haveli regarding regularisation of Primary Teachers in Govt. Representation was referred to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments within 30 days from receipt of the letter dated 11/04/2018. Response was not received.

Shri H. C. Vasava, Hon'ble Member, NCST discussed the issue with the AAO, Primary Education, Silvassa and the petitioner in the sitting held on 24/05/2018. After discussions in the sitting on 24/05/2018, Commission suggested / recommended that information and action proposed to be taken on the following points may be sent to the NCST within a month from receipt of the minutes.

- (i) Detailed information in respect of candidates appointed of in 2006-07 and process adopted for regularized the Teachers in different years. List of STs candidates appointed in 2006-07 and list of ST candidates regularized and ST candidates not regularized so far.
- (ii) TET condition may be waived for Scheduled Tribes candidates, those were appointed in 2006-07, if at that time TET criteria for appointment of teachers was not in force. The case of ST candidates may be considered on the humanitarian and economic grounds, perhaps they have crossed the age limit.

The reply / action taken report on the recommendations of the Commission was not received from the Dadra & Nagar Haveli, Administration. The sitting was fixed by Shri H. C. Vasava, Hon'ble Member, NCST on 28/08/2018 at 1:00 P.M. onwards to discuss the issue with the authorities of Dadra & Nagar Haveli Administration and petitioner. The Department of Primary Education, Silvassa had deputed AAO / HO Primary Education, D&NH to attend the sitting. In the sitting, petitioner(s) were present.

The Hon'ble Member asked the representative of Dadra & Nagar Haveli Administration to told the action taken by them in the matter. The representative informed that proceedings of sitting dated 24/05/2018 was not received by them in time. Therefore, the action taken by the Department could not be brought. The suggestions / recommendations of the present sitting will be considered by the Administration for providing justice to the STs. The petitioner again informed that the Administration is not taking positive action to redressed the grievance and requested for justice.


