

Minutes of the sitting held in the NCST, Lok Nayak Bhawan, New Delhi on 26/09/2018 at 4:30 P.M. under the chairmanship of Ms. Anusuiya Uikey, NCST in the case of Ms. Poonam Madhuri Toppo and Shri Lokesh Kumar Meena, Male Nurse, and others G.B. Pant Hospital, R/o WZ - 276/17, IInd floor, Inderpuri, New Delhi regarding injustice with Scheduled Tribe employees working in the Health & Family Welfare Department, Govt. of NCT of Delhi.

Representations of Ms. Poonam Madhuri Toppo and Shri Lokesh Kumar Meena, Male Nurse, G.B. Pant Hospital, R/o WZ - 276/17, IInd floor, Inderpuri, New Delhi regarding injustice with Scheduled Tribe employees working in the Health & Family Welfare Department, Govt. of NCT of Delhi.

The issue was discussed in the sitting on 13.10.2017, 20.02.2018 and 11.06.2018 convened by NCST with the Officers of Health and Family Welfare Department, GNCTD, Services Department, GNCTD and the petitioners. In the sitting held on 11.06.2018, the NCST suggested / advised that Health & Family Welfare Department should submit the report to the NCST within fortnight on the following points, after that a sitting will be convened with the Chief Secretary, Govt. of NCT of Delhi and Principal Secretary, Health & Family Welfare Department to resolve the issue.

- (i) All 42 Scheduled Tribes candidates to be regularized from the date of vacant posts i.e. DPC, 2011.
- (ii) All DPC held after 17/05/2018 in case of nursing posts withhold immediately.
- (iii) Total sanctioned posts, filled posts and vacant posts in Nursing category and status of backlog of ST posts.
- (iv) Other vacant posts reserved for Scheduled Tribes in Health & Family Welfare Department be filled.
- (v) The roster register in respect of nursing staff be provided.
- (vi) Liaison Officer in the Health & Family Welfare Department be appointed.

The Health and Family Welfare Department has furnished the action taken report on the suggestions of NCST and informed that the case is pending before the Hon'ble CAT in C.P. No. 347/2015, vide letter No. F.8(140)/2017/H&FW/Nursing/2017/2341 dated 16.07.2018. Petitioners met Hon'ble Vice-Chairperson, and requested for justice. The Hon'ble Vice-Chairperson, fixed the sitting on 29.08.2018 to discuss the matter with the Secretary, Health and Family Welfare Department, GNCTD and the petitioners. The Secretary, H&FW, GNCTD did not appear before the Commission. Therefore, Hon'ble Vice-Chairperson refixed the sitting on 26.09.2018 at 4.30 PM to discuss the issue with the Chief Secretary, GNCTD, Secretary, H&FW, GNCTD Delhi, Secretary, Services Department, GNCTD and the petitioners for find out the solution.

The Hon'ble Vice-Chairperson asked the petitioners to explain the problems faced by them. The petitioners informed that the H&FW Department not cooperating with them. As per directions of Hon'ble Chairperson, NCST, they met with the Chief Secretary, GNCTD for help, but no concrete action had been taken by H& FW Department. The posts are lying vacant and requested for justice.

The Secretary, H&FW Department informed that the Roaster is under finalization. The Liaison Officer has also been appointed by the H&FW Department. The Department will take action after the decision/ direction of the Hon'ble CAT in C.P. No. 347/2015. The representatives of Services Department, GNCTD informed that the matter is purely administrative in nature and action needs to be taken by H&FW Department and as no action is pending in Services Department. Secretary, H&FW Department assured that the petitioners can meet him on the next day of the sitting for presenting their grievance in detail.

After detailed discussions, it was decided that H&FW Department should submit the report to NCST on the following points within a month.

- (i) As assured by the Secretary, H&FW Department, petitioners can meet him any day for presenting their case.
- (ii) Roster should be prepared within a month by adopting the due procedure. The cases for promotion of all affected ST persons should be examined as per latest judgment of Hon'ble Supreme Court.
- (iii) The ST candidate promoted as Sr. Nursing Officer on Ad-hoc basis may be regularized as per rules.
- (iv) As special case, H&FW Department can constitute a DPC for considering the cases of affected ST persons.
