Minutes of sitting held in the NCST's Headquarters on 27/11/2018 at 11:30 A.M. under the Chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Manjeet Singh Chauhan, (R/o House No. 250, Gali No. 9, Block - G, Prem Nagar, Najafgarh, Delhi) and Shri Pratap Singh Chauhan regarding delay in issuing Joining Letter for regular teachers (TGT, Computer Science) by Directorate of Education, Govt. of NCT of Delhi.


List of participants is annexed.

Shri Manjeet Singh Chauhan and Shri Pratap Singh Chauhan (candidate of TGT-Computer Science, under the post code 192/14 of the Directorate of Education, Government of National Capital Territory of Delhi) vide representation dated 24.09.2018 has stated that the Directorate of Education, GNCTD has issued the offer of appointment for the post of TGT on 25.04.2018, but the department has not issued the joining letters. The NCST took up the matter with the Directorate of Education, GNCTD vide letter dated 03.10.2018 for facts and comments. The response was not received from the department.

Hon'ble Member, Shri H.C. Vasava fixed the sitting on 27.11.2018 to discuss the matter with the Secretary, Education Department, GNCTD and the petitioner (s). The Secretary, Education vide letter No. PPS/SE/2018/773-774 dated 26.11.2018 deputed Special Director (Admin) for attending the sitting and requested for exemption from attending the sitting as he was engaged in other meeting. Petitioners were also present in the sitting.


Hon'ble Member asked the petitioner (s) to explain the facts and difficulties. The petitioner (s) informed that the Department of Education had issued the offer of appointment letter (s) in April, 2018 and joining letter has not been issued so far, as on today unemployed. The Education Department is harassing by not issuing the joining letter.

Hon'ble Member asked the representatives of Education Department to explain the action taken by the Department in the matter. The representatives of Education Department informed that the Department has sought the clarification in respect of qualification of TGT Computer Science from the All India Council of Technical Education (AICTE) vide letter No. DE/4(20)/1/E-IV/ Appt. TGT(CS)/2017 part-iv 4466 dated 20.11.2018, as the basic eligibility

qualification possessed by the representationist and other candidates is not accordance with the Recruitment Rules for the said post. It is also informed that both the candidates are MCA therefore, Department will issue the joining letter on receipt of the comments of AICTE.

After discussions, the Hon'ble Member suggested that the Department of Education should approach the AICTE to expedite the views/ advise in the matter. Action taken/ to be taken by Department of Education be informed to the Commission within a month. After that next sitting in the matter will be fixed by the Commission.
