Minutes of sitting held on 22/01/2019 at 11:30 AM at Headquarter, NCST New Delhi under the Chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Kanchanbhai Shanabhai Vasava, R/o at Ambavadi, Taluk - Dediypada, District - Narmada, Gujarat regarding injustice to the Scheduled Tribes in assistance by Milk Co-operatives of Bharuch & Narmada.

Representation dated 28/05/2017 received from Shri Kanchanbhai Shanabhai Vasava, R/o at Ambavadi, Taluk - Dediypada, District - Narmada, Gujarat regarding injustice to the Scheduled Tribes in assistance by Milk Co-operatives of Bharuch & Narmada.

The issue was discussed in the sitting held on 04.10.2017 at New Delhi, Tour undertaken by Hon'ble Member, Shri H.C. Vasava on 02.04.2018 to 04.04.2018 to assess the facts and realities, sitting held on 07.06.2018 and further sitting held on 30.07.2018 at Gandhinagar, Gujarat. In the sitting held on 30.07.2018 under the Chairmanship of Shri H.C. Vasava, Hon'ble Member NCST, after discussions it was suggested that the point-wise information and action taken / to be taken on the recommendations / suggestions of the Tour Report dated 02/04/2018 to 04/04/2018 of Gujarat State which includes this case should be sent to the NCST within 15 days from the date of sitting. After receipt of the action taken report from the Registrar, Co-operative Societies, Gujarat, the further course of action will be decided by the Commission.

The minutes of sitting was communicated to the concerned agencies vide letter dated 23.08.2018. The Registrar Cooperative Societies, Gandhinagar vide letter No. DSM/01/GG-3/1719/2018 dated 04.10.2018 has furnished the brief of action taken by them in the matter. In this letter it has been mentioned that "The authority imposed penalty of Rs. 4000/- and Rs. 20,000/- which was paid by Managing Director of milk union in his personal capacity".


The Hon'ble Member decided to discuss the matter with the Registrar, Cooperative Societies, Gandhinagar and Managing Director, Gujarat Cooperative Milk Federation Limited, Anand and the petitioner in a sitting on 16.01.2019, but the sitting

was postponed for 22.01.2019. In the sitting dated 22.01.2019, the representatives of Registrar, Cooperative Societies, Gandhinagar, representative of Dhudhara Dairy, Bharuch and petitioner were appeared before the Commission. But no one was appeared from Gujarat Cooperative Milk Federation Limited, Anand.

The Hon'ble Member asked the representative of the Registrar, Cooperative Societies, Gandhinagar to explain the facts regarding payment of Rs. 4000/- and Rs. 20,000/- by MD, Milk Union as mentioned by the Registrar, Cooperative Societies, Gandhinagar in their letter dated 04.10.2018. The representative of Registrar, Cooperative Societies, Gandhinagar was unable to explain the facts in detail. The Hon'ble Member asked the petitioner to explain the problems and grievances. The petitioner again pointed out that the Management of Bharuch, District Cooperative Milk Producers Union Limited indulge in corruption and still doing financial misuse. He had also given a complaint dated 22.01.2019 (in the sitting) regarding tour of non- employees and non-members of District Cooperative Milk Society, from 11.09.2018 to 15.09.2018 from Ahmedabad to Chandigarh and back to Ahmedabad (annexure-II). During the sitting, Hon'ble Member also discussed the matter with Managing Director, Bharuch District Cooperative Milk Society over phone on the issue. Reply/ information given by Managing Director was not satisfactory.

After discussions with the representatives of the Registrar, Cooperative Societies and representative of Dhudhara Dairy, Bharuch, the Hon'ble Member suggested that the copy of the complaint dated 22.01.2019 of Shri Kanchanbhai S. Vasava should be forwarded to Registrar, Cooperative Societies, Gujarat for necessary action. The complaint and case should be re-examined by the Registrar, Cooperative Societies, Gujarat. The detailed report in the matter should be submitted to the Commission within a month from receipt of the proceedings of the sitting, for deciding further course of action.
