Vasava, Hon'ble Member, National Commission for Scheduled Tribes (NCST) in the case of Shri Kishan Lal Meena, Senior Section Engineer, C/o Coaching Depot Officer, Coach Care Center, Anand Vihar Terminal, Delhi regarding promotion from 31.07.2015 instead of 28.04.2016.

Shri Kishan Lal Meena, Senior Section Engineer, Carriage and Wagon Department, O/o Coaching Depot Officer, Coach Care Center, Anand Vihar Terminal, (Railways) Delhi vide representation dated 24.10.2017 has alleged regarding promotion from 31.07.2015 instead of 28.04.2016. The NCST vide letter No. KLM/8/2017/MRLY1/SEPROM/RU-I dated 24.11.2017 has sought facts and comments from Chairman, Railway Board and General Manager, Northern Railways, Delhi. The Northern Railways vide letter No. 220-E/1258/18-NCST/DLI/2017/RP-cell dated 02.01.2018 has forwarded the facts and comments in the matter, which was referred to the petitioner for satisfaction.


The petitioner vide rejoinder dated 14.08.2018 has refuted the facts and requested for justice, the rejoinder was sent General Manager, Northern Railways for further facts and comments on 29.08.2018. The response was not received from the Northern Railways, the Hon'ble Member, Shri H.C. Vasava decided to discuss the issue with the Railway Authorities and petitioner to resolve the grievance on 16.01.2019. The said sitting was postponed for 22.01.2019.

In the sitting, the representatives of Northern Railways had submitted a letter No. 220-E/1258/18-NCST/DLI/18/RP-cell dated 16.01.2019 of the General Manager (P), wherein it had been mentioned that the applicant has been granted the benefits of promotion w.e.f. 31.07.2015 instead of 28.04.2016 vide DRM/ New Delhi's letter No. 939-E/2/Misc.P-5 dated 14.01.2019. In addition to that, a copy of the letter dated 16.01.2019 of the petitioner given to Railway Authority, wherein it had been mentioned that he is satisfied with the action taken by the Railway Authorities, was also placed in the sitting.

The Hon'ble Member asked the petitioner that whether he is satisfied with the action taken by the Railway Authorities. The petitioner endorsed the information given by the Railway Authorities and informed that he is satisfied.

After discussions, the Hon'ble Member observed that the case is successful and therefore, decided that the case should be closed.
