The issue of non-attendance of senior officers from Government of Maharashtra in the Sitting convened by the National Commission for Scheduled Tribes was discussed in the last Sitting of the Commission and it has been decided that the following actions are to be taken in pursuance of the powers conferred under Article 338A of the Constitution to this Commission.

- (a) Issue of summons against senior officers failing which summons to be issued to the Chief Secretary, Government of Maharashtra.
- (b) Issue of warrants to defaulting officers through Maharashtra Police for enforcing attendance.
- (c) Recording observations of the Commission in the Annual Confidential Reports of the absentee officers.
- (d) Recommend any other action deemed appropriate to the State Government as well as to the Department of Personnel and Training in the Government of India.
