

Whereas the National Commission for Scheduled Tribes, as per the Constitutional mandate and as per powers conferred upon it under Article 338A of the Constitution of India has decided to investigate into the aforementioned matter. The information has not been received in the Commission. (It is mentioned that action taken/ to be taken on the recommendations of NCST in its sitting held on 08.04.2019 has not been received in the matter from the concerned department/Agencies).

Miss Anusuiya Uikey, Vice- Chairperson, National Commission for Scheduled Tribes has fixed a sitting in the Commission on **14.05.2019 at 02:00 P.M.** in the Commission's Conference Room, 6th Floor, 'B' Wing, Lok Nayak Bhawan, Khan Market, New Delhi for investigation/inquiry/action to be taken in the matter.

Accordingly, you are requested to appear **in person** for examination before the Hon'ble Vice-Chairperson on the above scheduled date and time along with full facts and all relevant original records/documents pertaining to the case. The Petitioner may also be advised to be present in the Sitting.

4. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
