- Sub: Representation from Shri Jalpathi Bandu Madavi, Ghogervadi, Post-Mandva, Tehsil-Kinwat, District - Nanded (Maharashtra) & others regarding death of Scheduled Tribe person and misbehaviour and harassment with STs by the Forest and Police Officials.

Whereas the National Commission for Scheduled Tribes (NCST), as per the Constitutional mandate and as per powers conferred upon it under Article 338 A of the Constitution of India has decided to investigate into the aforementioned matter. An action taken report on the Commission's recommendations in the case is still awaited despite passing of stipulated periods.

2. Shri Nand Kumar Sai, Hon'ble Chairperson, National Commission for Scheduled Tribes has fixed a Sitting in the Commission at New Delhi on **10.06.2019 at 02.00 P.M** for investigation/inquiry/ action to be taken in the matter.

Accordingly, you are requested to appear in person for examination before the Hon'ble Chairperson on the above scheduled date and time along with action taken report on the Commission's recommendations, full facts and all relevant original records/documents pertaining to the case. The petitioner may also be advised to be present on the day of Sitting in the Commission.

5. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
