Accordingly, you are requested to appear in person for examination before the Hon'ble Vice-Chairperson on the above scheduled date and time along with action taken report on the Commission's recommendations, full facts and all relevant original records/documents pertaining to the case. The petitioner may also be advised to be present on the day of Sitting in the Commission.

5. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (6) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
