Minutes of sitting held in the NCST's Headquarters on 26/09/2019 at 03:00 P.M. under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST on the issues related with the Chittaranjan Locomotive Works (CLW), District- West Burdwan, (West Bengal).

List of participants is annexed.


2. The Zonal Secretary, All India SCs and STs Railways Employees Association, CLW had requested for restoration of former logo of CLW (Bow & Arrow i.e. Teer& Kaman) vide representation dated 01.12.2018. Accordingly, the matter was referred to Chairman, Railway Board on 13.02.2019 for furnishing the facts and comments. The following issues was brought with the notice of Hon'ble Chairperson, NCST when the Commission was on visit of West Bengal (i.e. on 25.02.2019).

- (a) Restoration of former logo of CLW (Bow & Arrow i.e. Teer& Kaman).
- (b) Non permission for installation of statue of Shri Jaipal Singh and Dr. B.R. Amedkar in the office of All India SCs & STs Railway Employees Association, CLW.
- (c) Threatening to office bearers of All India SCs & STs Railway Employees Association, CLW by the Management.
- (d) Acquisition of land for setting up of Chittaranjan Locomotive Works and implementation of RR policy for the affected STs persons.

3. The Hon'ble Chairperson, NCST decided to discuss the issue with the Chairman, Railway Board and GM, CLW and office bearers of Association on 01.03.2019 at 05.00 PM at New Delhi. Accordingly, the sitting notice was issued on 25.02.2019. The sitting scheduled for 01.03.2019 was postponed for 30.04.2019 and subsequent the sitting was postponed further (on 30.04.2019).

4. The Chittaranjan Locomotive Works vide letter No. GMA/Resv.NC/2019 dated 29.04.2019 furnished the facts and comments on the above issues. The Railway Board vide letter No. 2019/PR/11/5 dated 06.05.2019 had stated that in the year 2007 Railway Board took a decision that in order to ensure uniformity and the sense of belongingness to the Indian Railways, all the Railways units should discontinue the use of their individual logo forthwith and common logo. In view of the directions CLW had discontinued the earlier logo of Bow & Arrow from 12.03.2007 and started using a common logo i.e. Indian Railways logo.

5. Hon'ble Chairperson, NCST fixed the sitting for 26.09.2019 at 03.00 PM. Accordingly, the sitting notice issued on 18.09.2019 to Chairman, Railway Board, New Delhi and General Manager, CLW, District- Burdwan and the petitioner.

6. The Chairman, Railway Board vide DO letter No. 2019/E(SCT)II/2/7 dated 25.09.2019 had deputed Member Traction, Railway Board along with concerned officers to attend the sitting. The General Manger, CLW was also present in the sitting. The Zonal President, Zonal Secretary and Zonal Additional Secretary of the Association were present in the sitting.


7. The Hon'ble Chairperson asked the office bearers of the All India SCs and STs Railway Employees Association, CLW to explain the issues and difficulties. The office bearers informed the point wise issues. The brief of the issues and answers given by the CLW and Railway Board was as under:

- (a) **Restoration of former logo of CLW (Bow & Arrow i.e. Teer & Kaman)-** The office bearers of Association informed that the logo was provided under agreement between the Association and Management. But this has been withdrawn by the Railway authority without considering the sacrifice of the Santhal people. The logo (Bow & Arrow) should be restored.

The GM, CLW informed that as per directive of Railway Board the logo of Bow & Arrow of CLW discontinued from 12.03.2007 by the Management and started using Indian Railways logo. The representative of Railway Board informed that detailed proposal requires to be prepared by the General Manager, CLW for re-consideration by the Railway Board for use of Bow & Arrow in CLW.

After detailed discussions with the officers of Railway Board, General Manager, CLW and office bearers of Association, Hon'ble Chairperson, NCST recommended that CLW should move the proposal in consultation with the office bearers of the All India SCs and STs Railway Employees Association of CLW with supporting document to Railway Board for re-consideration for restoration of logo i.e. Bow & Arrow to CLW within a month.

- (b) **Non permission for installation of statue of Shri Jaipal Singh and Dr. B.R. Amedkar in the office of All India SCs & STs Railway Employees Association, CLW-** The General Manager, CLW informed that Railway Board had issued directives regarding non- installation of statues, plaques, memorials and murals in Railway premises vide their letter No. 91/LM(B)/3/8/Statue dated 29.11.2000. However, the statue of Dr. B.R. Amedkar installed in the premises of the office of Association.

- (c) Threatening to office bearers of All India SCs & STs Railway Employees Association, CLW by the Management- CLW Management not threatening to any office bearers of the Association.
- (d) Acquisition of land for setting up of Chittaranjan Locomotive Works and implementation of RR policy for the affected STs persons- In this respect, the General Manager, CLW reiterated the facts and comments submitted by CLW vide its letter dated 29.04.2019 to the NCST

8. The office bearers of Association demanded for entrusting the work of Fishing and Cultivation to the affected families on the ponds and land under the control of Management of CLW. The General Manager, CLW informed that the Management through tender giving the works of Fishing & Cultivation on the ponds and land of the CLW. This demand will be examined by the Management.

9. In addition to the above, office bearers of the Association raised that children of displaced family persons will be given priority for admission in the school (s) run by the CLW Management. The General Manager, informed that the school (s) run by CLW Management is basically for the children of employees of CLW. This demand will be examined by the Management.

10. After detailed discussions with the General Manager, CLW and office bearers of All India SCs and STs Railway Employees Association, CLW, Commission recommended that the Management of CLW should consider the demand of the Association for entrusting the work of Fishing & Cultivation to the affected ST families, in view of the "Right to Use" policy. The priority be given for admission to children of affected ST families in school (s) run by the CLW Management. The CLW Management should also work for the welfare and development of Scheduled Tribes and areas of the CLW on the line of Damodar Valley Corporation (DVC).
