Sir,

In compliance of the minutes of sitting held in the National Commission for Scheduled Tribes on 14/10/2019 at 12:30 P.M. under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, National Commission for Scheduled Tribes, certain documents are submitted at NCST, on preliminary examination of documents it is observed that :-

1. Complete original file comprising of approval to revised seniority list issued vide office order No.DTL/101/2019-20/HR-DM(HR)-II/65 dt 28.06.2019 with the approval Ex. Secretary Power, GNCTD and CMD,DTL is not submitted. As this office order was submitted at NCST as compliance vide your letter F.DTL/101/2019-20/HR-DM(HR)-II/582 dt 15.07.2019, the file is part and parcel of this case as the said approval and revised seniority list required to be forwarded to DoPT.
2. It is also observed that the submitted copy of reservation roster register is not complying the DoPT guidelines and instructions and GOI notifications.

As the matter is considerably delayed it is once again requested to submit the requisite file and original reservation roster register at NCST before 13.11.2019.
