Minutes of sitting held in the NCST's Headquarters on 04/09/2019 at 03:00 P.M under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST in the case of Shri S.L. Negi, Assistant Registrar, College of Home Science, CSK HP Krishi Vishvavidyalaya, Palampur, District- Kangra, (Himachal Pradesh) regarding harassment by University authorities.

List of participants is annexed.

Shri S.L. Negi, Assistant Registrar, College of Home Science, CSK HP Krishi Vishvavidyalaya, Palampur, District- Kangra, (Himachal Pradesh) vide representation dated 19.01.2019 had alleged the Vice Chancellor has not given promotion to him being a Member of Scheduled Tribe community. The NCST vide letter dated 29.01.2019 has referred the matter to Chief Secretary, Govt. of Himachal Pradesh for facts and comments. An endorsement sent to Secretary to Hon'ble Governor, Himachal Pradesh for necessary action. The Registrar, CSKHPKV vide letter NO. QSD-7-323/85-CSKHPKV(Estt). Vol.II- 10343-44 dated 06.03.2019 has furnished the facts and comments. This letter was referred to Shri S.L. Negi by the Commission on 01.04.2019 for information and satisfaction. Shri S.L. Negi vide representation dated 12.04.2019 & 10.07.2019 has refuted the facts and requested for sitting to resolve the case. The Hon'ble Chairperson fixed the sitting for 30.07.2019 which was deferred for 21.08.2019. Further, deferred and fixed for 04.09.2019 at 03.00 PM. The sitting notice was issued to Principal Secretary, Agriculture Department, Govt. of Himachal Pradesh and the Registrar, CSKHPKV on 28.08.2019.

The Principal Secretary, Agriculture Department, Govt. of Himachal Pradesh vide letter No. Agr. B-B(15)-9-2018 dated 05.08.2019 had intimated that the appointments or promotion or any other establishment matters of the CSKHPKV is being carried out by the CSKHPKV. The CSKHPKV is the autonomous body and free to carry out/ deal such cases at his own and there is no any involvement of the Government. The Registrar of CSKHPKV has already been directed to ensure the personal appearance before the Commission. It was also requested for exemption of personal appearance.

In the sitting dated 04.09.2019 at 03.00 PM the Registrar, CSKHPKV, Palampur and petitioner were present. The petitioner informed that the Registrar, CSKHPKV is not empowered to take a decision in the matter, which was also supported by the Registrar.

As per discussions with the Registrar, CSKHPKV and the petitioner, the Hon'ble Chairperson cancelled sitting and decided that the Vice Chancellor of the CSKHPKV and the then Registrar, CSKHPKV called for discussion to resolve the issue. The next sitting will be convened very soon.
