Sir,

I am directed to refer to the subject cited above and to say that copy of the minutes of Sitting held on 03/09/2019 at 04:00 P.M. under the Chairmanship of Dr.Nand Kumar Sai, Hon'ble Chairperson, National Commission for Scheduled Tribes in the matter was circulated for necessary action, vide NCST's letter of even No. dated 03.10.2019.

In this context, it is stated that the description mentioned in the paragraph 2 of the minutes of the sitting dated 03.9.2019, which is reproduced below having some typographical error:

“Director, NIT, Kurukshetra vide letter No. D/2019 dated 28.05.2019 had informed that the victim was an ex- student of 2013-17 batch of B. Tech (ECE). He was not resident of Hostel and was staying in the Hostel with his friends with the knowledge and permission of competent authority of Hostel administration. The NIT, Hostel Administration had provided all the information to the Police in the matter”.

Hence, the Paragraph 2 of the minutes of sitting held on 03.9.2019 should be read as under:-

“Director, NIT, Kurukshetra vide letter No. D/2019 dated 28.05.2019 had informed that the victim was an ex- student of 2013-17 batch of B. Tech (ECE). He was not resident of Hostel and was staying in the Hostel with his friends without the knowledge and permission of competent authority of Hostel administration. The NIT, Hostel Administration had provided all the information to the Police in the matter”.
