MINUTES OF THE SITTING HELD BY SMT. MAYA CHINTAMN IVNATE HON'BLE MEMBER NCST ON 25.9.2019 ON THE PETITION RECEIVED FROM SHRI K.N. RAO REGARDING GRANT OF HOUSE SITES PATTAS TO POOR PEOPLE BELONGING TO ST COMMUNITY.

- 2. During the sitting the petitioner informed that there are about 475 members in the society and they are living for the last several years as Agricultural coolies without having any kind of house sites or houses. They are unable to enroll them selves in votes list for not having houses and also not able to reach the benefits provided by the Government under several welfare schemes including civil supplies. They are leading a measurable life in the village. The Members are homeless and landless poor persons. Several people are living in burial grounds also.
- 3. It was informed that 35 Acres of 'Poromboke' land in D.No. 203 of Chamallamudi Village. Vatticherukur Mandal, Guntur District. The petitioner requested to kindly provide house sites for the society members who belong to ST people and necessary instructions may be issued to the concerned authorities for consideration of their request.
- 4. The districts officials informed that the Tahsildar Vatticherukuru has submitted report stating that as per the Revenue records of Chamallamudi Village the Sy. No. 203 are classified as "CHERUVU POAMBOKE" and there is a ban for conversion of water bodies in to A.W.D. Hence, it is not possible for sanction of house sites in Sy. No. 203 Chamallamudi Village and it is also reported that, in the enquiry it revealed that out of 35 land less people above, 7 persons are not residing in the village, one person is unmarried, one person was died and 9 persons are eligible for sanction of house sites and included in the beneficiaries list to distribute the house site Pattas on 25.3.2020. Remaining 17 persons are having house sites/houses in the Village.
- 5. Further, the Tahsildar reported that 69 beneficiaries (SC-29, ST-13, BC-21 and others-6) were identified in Chemallamudi Village for grant of house sites under "Pedalandariki Illu" of Navaratnalu Programme and for distribution on 25.3.2020. It is also submitted that no Government land is available in Chemallamudi Village. Government has proposed to acquire land for distribution of house sites for above beneficiaries.
- 6. The district officials also informed that the Government of Andhra Pradesh has taken up a programme called "Pedalandariki Illu" (Housing for all) and has ordered for selection of eligible beneficiaries by door to door survey for issue of house sites on a saturation mode to all the eligible people. It is a priority programme and all the eligible people will be granted house site Pattas by 25.3.2020, if necessary, by acquiring private patta land.

After detailed discussion it is observed that earlier petitioner had already submitted document along with the list of S.T. people to Collector Guntur since 2007 but Collector Guntur on his reply submitted of the Commission that only 69 beneficiaries (SC-29, ST-13, BC-21 and other 6) were identified. So the Hon'ble Member, National Commission for Scheduled Tribes advised the Collector Guntur that as assured by him earlier should conduct a fresh enquiry/verification of documents submitted by petitioner and all the eligible S.T. people should be given "Pattas" by March 30th 2020. An action taken report should be submitted to the Commission the earliest.
