Matter: Grievance of Smt Koduri Meena Kumari, National President (Women Wing), Forum fo Social Justice, Guntur (AP) regarding murder of Shri K Anjaneyulu s/o Smt. K. Mangamma, Guntur (AP) and the implementation of rehabilitation package as per GOMS No. 95.

The list of Participants is annexed.

2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
3. The petitioner appeared along with her representative who stated that the petitioner's son was brutally murdered on 30th July, 2017. All the accused were arrested. The petitioner further alleged that benefits, as per GOMS No. 95 have not been extended to the aggrieved family so far. The family has however received the total grant of Rs 8, 50,000/- and other benefits are yet to be received.
4. The District Collector and Superintendent of Police of Guntur District did not appear before the Commission due their pre occupation and the late receipt of Communication from the Commission. The Ho'ble Member however took note the status report as received from the District Collector.
5. After hearing the Petitioner and his representative, Hon'ble Member decided to fix next sitting shortly to hear this matter further.
