Matter: Shri Swarnakamal Sai, F-01, Jail Road, Devender Nagar, Raipur regarding compensation for false advertisement by BPCL for award of RO dealership.

2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.

3. The representative of the petitioner stated that the petitioner applied for RO dealership as per BPCL advertisement between the 190 - 95 milestones on NH-49 in Raigarh district under category 3 for which the applicant was required to acquire land. After submitting the application, the applicant entered into an agreement for purchase of land on the specified stretch and paid Rs 2,00,000 towards therefor. Later, on a verification from NHAI, it was told that the piece of land identified by the petitioner falls into Janjgir Chanmpa and not in Raigarh district as advertised by BPCL and in that case the petitioner would not be entitled for allotment of the dealership. Due to the wrongful information given in the advertisement, the petitioner was not only misled, but also lost Rs 2, 00,000. He then approached the BPCL vide his letter dated 1st October, 2019 for compensation.

4. The ED in BPCL apprised the Commission that BPCL still stands by the said advertisement and clarified that the said location was correctly

advertised. It was also added that the locations have been mentioned in the advertisement after a verification by NHAJ.

5. The Commission feels that in the first instance, the issue needs a clarification on the point of location both from NHAJ and also the Revenue Department of the Government of Chhattisgarh. It accordingly recommends that a reference be made to both NHAJ and Revenue Department of the Government of Chhattisgarh to categorically ascertain, village wise, under which Revenue district(s), the stretch of 190 - 95 milestones on NH-49 falls. After obtaining their comments, the Commission would take up the matter with BPCL.
