During the sitting the petitioner along with some other affected persons stated that due to execution of the Rukuda Dam Project they have been displaced. At present they have been staying at a place where the Forest officials have been objecting their existence. They have been deprived of basic amenities and bare necessities of life. They don't have Record of Right and other legitimate rights. Due to inaction of the Government they have been leading a pitiable and tragic life.

In response the District Magistrate and Collector who was present before the Commission stated that he is aware of the fact. He assured that all possible steps shall be taken for ensuring the Land rights, bare necessities and basic amenities in the area where they have been temporarily settled.

Hon'ble Member, National Commission for Scheduled Tribes, who chaired the hearing recommended the District Collector to ensure the Land Rights, proper rehabilitation and resettlement of the displaced tribal families and the promises made by the District Collector be implemented in letter & spirit, without fail and send the ATR.

Action taken Report after due compliance of the recommendation must be provided to the Commission within 15 days.
