Minutes of the Proceedings of the Sitting held under the Chairmanship of Hon'ble Chairperson, NCST, to discuss the case of Shri O. P. Meena, Deputy Director (HPA-II), Central Electricity Authority, HPA-II Division, 7th floor, Sewa Bhawan, R.K. Puram, New Delhi regarding relaxation in qualifying service for promotion from AD-II to AD-I in CEA.

1. Sitting was held on 22.9.2016 at 1200 Noon under the Chairmanship of Hon'ble Chairperson, NCST for discussion on the representation of Shri O. P. Meena, Deputy Director (HPA-II), Central Electricity Authority, HPA-II Division, 7th floor, Sewa Bhawan, R.K. Puram, New Delhi requesting for relaxation in qualifying service for promotion from AD-II to AD-I in CEA.
2. List of participants in the Sitting is as at Annexure A.
3. Secretary, Ministry of Power, Govt. of India vide letter No. A-60016/20/2015-Admn.-1(Part-1) dated 21/09/2016 has requested for exemption of his presence due to exigencies of work and nominated Smt. Anju Bhalla, Joint Secretary to attend the hearing. Hon'ble Chairperson allowed the same.
4. During discussion the Hon'ble Chairperson has asked the petitioner to present the case, before the Commission.

6. Smt. Anju Bhalla, Joint Secretary explained the facts and stated that his representation has already been forwarded to DoPT and UPSC for their advice.
