



A representation dated 27.07.2016 was received from Shri (Dr.) R. Vinay Kumar, No. 140/A, II Block, II Stage, Nagarbhavi, Bangalore against administration of Kidwai, Memorial Institute of Oncology (KMIO), Bangalore.

He has Stated that on completion of residency training and two years of senior residency at AIIMS, New Delhi he was successful in competing for UR POST of Assistant Professor of Radiation Oncology at KMIO, Bangalore. He authored around 8 papers as a first author in peer-reviewed international cancer journal in the last four years after joining KMIO.

He was troubled by the institute before accepting travel grant of Japanese Breast Cancer Society in 2015. Baseless and defamatory circulars were posted on notice board to initiate departmentally enquiry against him and subsequently stop him from availing Young Investigator Award 2016 awarded by Denmark based professional body in Adelaide, Australia and getting promoted to the post of Associate Professor for which he was due in August 2016.


He was threatened of incrimination in fabricated sexual harassment case and physical and professional harm in past and present respectively. Successive Directors (Dr. M. Vijaya Kumar and Dr. Lingegowda) have encouraged sub-ordinate faculty members and residents to slander his name based on the public access of the above mentioned proceedings of the Commission. He requested the Commission to look into this matter and advise.

Hon'ble Vice-Chairperson, NCST fixed up a Sitting on 21.09.2016 at 03.00 pm to discuss the matter with the Principal Secretary (Medical Education) Deptt. Health and Family Welfare, Govt. of Karnataka and The Director, Kidwai Memorial Institute of Oncology, Autonomous Institute of Govt. of Karnataka, Bangalore. Principal Secretary did not attend the hearing 21.09.2016.

Director, Kidwai Memorial Institute of Oncology, Bangalore who attended the hearing has promised that no discrimination has been meted out to him and all the delay in paper work which the applicant has been referring to is only on account of administrative reasons. All help which ever could have been provided to him, have been provided and will continue to help him, for his career development. If any issue is there he can always consult the Director at any time.

The Commission feels that since the Director of the Institute where the applicant is working have attended and apprised the position there seems to be nothing left to be directed for action except that the applicant should not be discriminated on any count. The applicant is free to meet the Director at any time. Application if any can be endorsed to the Commission for follow up if the institute is taking time on processing and onward submission.

The meeting ended with vote of thanks to the chair.
