


**Minutes of the Meeting held on February 08, 2016 at 11.30 in the Committee Room NCST.**

Minutes of the meeting:

1. The Hon'ble VC asked Dr Tsetan Namgyal to explain the grievances and the mode of victimization at his work place, based on the previous submitted complaints to the NCST. Dr Tsetan also apprised the Commission that his interview for the post of Professor was systematically delayed in order to give his juniors the opportunity to supersede him.
2. On the issue of the complaint against the dog issue, Prof B. Zutshi, the Acting Registrar, stated that it was Mrs Maneka Gandhi who had called Dr Tsetan Namgyal "Is ko phone Maneka Gandhi ne kiya". For the delay in holding the interview, he gave excuse for the procedural mechanism. Prof Zutshi provided the information on books purchased through Dr Namgyal's recommendation in the library and his foreign trips through university to plead that harassment was not done at the University level.
3. The Vice Chancellor, JNU, who happened to come for deposition on his own, gave the assurance to Hon'ble VC to hold the interviews for the post of Professor reserved for the ST at the earliest since he had joined just over a week ago.


Minutes of the Meeting held on April 29, 2016 at 11.30 AM in the Committee Room NCST.

Minutes of the meeting:

1. The Hon'ble Chairman NCST asked Prof. J. Kumar, Vice Chancellor to explain the reason for not approving Dr Tsetan Namgyal's candidature for the post of Professor (reserved for ST) at the selection committee held on March 29, 2016.
2. Prof J. Kumar, Vice Chancellor JNU, deposed before the Commission that Dr Namgyal had obtained 46 points whereas 50 is the cut-off for the selection for the post at any selection committee meeting.
3. The Hon'ble Chairman asked the VC if he could have intervened at the selection committee to increase those 3 points to enable him to get the appointment.
4. The Hon'ble Chairman further asked the VC and the other representatives of JNU to prevail upon the Executive Council members at JNU and increase just 3 points needed by Dr Namgyal since Prof J. Kumar himself would be chairing the EC meeting.
5. The Hon'ble Chairman asked the JNU representatives if there were any note of dissent in the said selection committee that considered Dr Namgyal's candidature?
6. On the issue of concentrated victimization of Dr Namgyal through the allegation of "killing and eating dog", Prof Kumar showed his total ignorance.
