## National Commission for Scheduled Tribes


Minutes of the Meeting held on April 20, 2016 at 3.30 PM in the Committee Room NCST.

Following were present:

1. Shri Ravi Thakur, Hon'ble Vice Chairman NCST

I was asked by the Hon'ble Vice Chairman, to explain the allegation that made against me by Prof.Amita Singh. Accordingly I told all stories in front of all the members present there in the meeting. After that, the Vice Chairman asked to explain Amita Singh in response to my submission and during her response she has mentioned the following points in her explanation to the commission.

1. Prof.Amita Singh narrated three instances in a sequence of crime that Dr.Namgyal has committed in the campus on a regular basis.
2. He is killing dogs in the campus for consumption on a daily basis where three instances she saw him killing dogs (four to five in number) while crushing under the wheel of his speeding car and also saw the killed dogs putting in the car dickey.
3. She said one day she saw him driving the car at very high speed on the campus where the roads are subtle, tiny and narrow and the students walking on the road side almost crush under the wheel of his car.
4. And one another instance she told the commission that Namgyal was again seen rush driving on the campus and this time a tea maker on the road side was almost crush to death.
5. In these all instances she informed the University higher authorities while mentioning the names of the former Rector Prof. Sudha Pai, former VC Prof. SK.Sopory and the present security officer whom she appraised about Namgyal's mischief of dog killings and rush driving numbers of time but let off saying forgive and forget as he has some family problem as his wife abandoned him hence his mantle condition is not stable.
6. She also alleged Dr.Namgyal while going out of the context of killing dogs and rush driving. She said with utter most frustration to the commission that how he can become professor easily where people like me gone through a lot of struggle and strife before becoming or reaching to that position.
7. She also said that people in JNU are very jealous of his Chairmanship and Dean of the school and they wanted to kill her because of my academic credential and also my affinity and closeness with Muslims, Dalits and SC/STs students in the campus as I am the only faculty on the campus who have enrolled the maximum number of minority students for research and teaching.
