Proceedings of the sitting taken by Hon'ble Vice-Chairperson who was also holding the charge of Hon'ble Chairperson, NCST on 10.11.2016 at 5.00 p.m. in the petition filed by Shri Shish Pal Singh & Shri Shyam Lal Meena for their promotion giving directions to the respondents for production of the records of the vacancies and reservation roster and for their promotion which has been unduly delayed.


Date of Sitting: 10.11.2016

List of officers present in the sitting is at Annexure-I.

A representation dated 26-11-2014 was received from Shri Shish Pal Singh and Shri Shyam Lal Meena, ACIO-II/WT working in the Intelligence Bureau under the Ministry of Home Affairs. They have submitted that the Department had allegedly used the vacancies of deputation quota in the year 1996 and DPC 2000-2001 for the regular promotion of the officers who belong to ST category and further had allegedly filled the loss of deputation quota with the diversion of the vacancies of ST category which had been occurred in the year 2003 & 2004 when they were eligible for their promotion to the rank ACIO-II/WT in the year 2003-04 and 2004-05. They have therefore requested for direction to the Department to produce the reservation roster maintained by Intelligence Bureau.

2. The matter was taken up with Ministry of Home Affairs vide communication dated 12-12-2014 followed by reminder dated 12-2-2015. A reply dated 16-1-2015 from the Intelligence Bureau were forwarded to the applicants vide this Commission's letter dated 23-2-2015. In response to this, a counter reply was submitted by the applicants vide their letter dated 9-3-2015 and communications were exchanged between the two and the applicants were not convinced about the reply submitted by

the Department, a hearing in this case was finally held on 10-11-2016 at 5.00pm, as in earlier occasions, nobody came for the hearing either from the Intelligence Bureau or from the Ministry of Home Affairs.

3. The representatives from the Intelligence bureau could not produce the original reservation roster maintained by them connected with the case. Though the case was narrated by them verbally, the stand could not be substantiated with documents.

4. Hence it has been advised to the Intelligence Bureau to present the original roster register concerned with the case of the applicant for verification of the same by the Commission on 28-11-2016 as without the same a decision could not be taken.

It is advised accordingly.
