#### NATIONAL COMMISSION FOR SCHEDULED TRIBES

PROCEEDINGS OF SITTING HELD ON 12.04.2022 CHAIRED BY SHRI ANANTA NAYAK, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF SHRI AMIT KUMAR, UTTAM NAGAR, NEW DELHI REGARDING ATROCITY AGAINST ST BY THE NON ST AND FRAMING HIM IN FALSE CASES BY THE WOMAN EMPLOYEE OF EPFO, NEW DELHI. POLICE INACTION AGAINST ACCUSED.

Date of Sitting: 12.04.2022 List of officers present in sitting is Annexed.

Shri Amit Kumar had submitted representation before the Commission stating that he is working as Senior Social Security Assistant at EPFO, Dwarka, New Delhi since, 2010. He was harassed by the EPFO officials and higher officers for last 05-06 years. On 10.12.2021, a contract employee Ms. Tanvi Sharma had physically assaulted upon him without any reason and she abused him on caste ground. Immediately, a complaint was made to the higher officers of EPFO and there was no action taken. Thereafter, the said lady employee has filed false Police complaint against him about stalking. The Police without verifying the facts, arrested him and he was released on bail by the Hon'ble Court. Earlier he had filed a Police complaint against the said lady for physical assault at workplace and caste abuse. The Police did not register FIR and also did not take any action against her. The Police took action only against him. He had also given documentary evidence of atrocity committed by lady employee but Police did not take cognizance. He requested the Commission to intervene in the matter and action taken against the accused.

It is further submitted that the petitioner has submitted another representation dated 10.02.2022 alleging that the accused lady employee has again filed a Police complaint against him regarding woman harassment. The Police is harassing him. The Department is also threatening to remove his services.

- 2. The NCST vide notice dated 11.02.2022 sought a report from Commissioner of Police, Delhi Police. However, no report was received.
- 3. Accordingly a sitting was held on 12.04.2022. In Sitting, the Deputy Commissioner of Police, Delhi Police, Dwarka and Assistant Commissioner of Police, Dwarka were appeared on behalf of the Police Commissioner, Delhi Police. The petitioner was also present.
- 4. In the Sitting, the petitioner has submitted grievances of atrocity, manhandling, physical assault and caste abuse by the lady contractual employee of EPFO. In this regard, he has mentioned the incident occurred on 10.12.2021. He has also raised grievances of misbehaviour against him and his family members by the Police officials of Dwarka Police Station during the investigation. Further, he raised harassment and discrimination by the higher officers of EPFO and threaten of removal from service by instituting of false inquiry.
- 5. The DCP, Dwarka, Delhi Police has briefed about the case. He informed the Commission that on the complaint of the petitioner, a case vide FIR No. 130/2022 dated 04.03.2022 under relevant sections of SC/ST (PoA) Act, 1989 at PS Dwarka Sector 23 was registered. Presently, the matter is under investigation. He also informed that the Police has

The Police has completed 80% of investigation in both cases and the cases will be decided with action taken based on findings of the Police inquiry. He has also sought apology on the behaviour of the Police officials for misbehave with the ST complainant. He assured that the inquiry will be conducted fair and action will be taken against the accused.

- 6. The case was discussed in detail. After hearing from both parties, the Commission decided that:
  - The Delhi Police will complete the investigation in fair and unbiased manner of the atrocity case within 15 days and will take necessary action against the accused.
  - The charge sheet will be submitted in time bound manner and it may be ensured that the accused be punished and also ensure speedy trial.
  - The petitioner will submit a detailed representation about atrocity at workplace and harassment / discrimination during the service period separately to the Commission. So that his service related grievances could be taken up with the Department concerned.
