**SITTING NOTICE**

Sub Representations of Shri Lachhu Oram & Ors. Rourkela Local Displaced, District Sundergarh, Odisha regarding land losers of acquired land for Establishment of Rourkela Steel Plant.

Whereas representations were received from Shri Lachhu Oram and others from Sundargarh District of Odisha praying for justice that after acquisition of their land, Rourkela Steel Plant was not paid compensation and employment to their family members.

2. Whereas Commission visited to Rourkela on 22.02.2016 to 24.02.2016 in connection with the displaced and Rehabilitation of tribals due to Setting up of erstwhile Hindustan Steel Plant (at present Rourkela Steel Plant) and minutes of the visit were sent to all concerned for taking necessary action.

3. Whereas consequent to the visit Hon'ble Chairperson had meeting with Chief Secretary, Govt. of Odisha on 19.08.2016 to 21.08.2016 (copy enclosed).

4. Whereas the Commission held Sitting on 17.10.2016 with the officers of Ministry of Steel, officers of Rourkela Steel Plant and officers of Sundargarh District to discuss the matter.

5. Whereas the Proceeding of the Sitting held on 17.10.2016 were sent to the concerned Departments for necessary action on the points emerged in the Sitting.

6. Whereas the reply of Steel Authority of India Limited, Rourkela Steel Plant dated 23.12.2016 has been received (copy enclosed).

7. Whereas a delegation headed by Shri Lachhu Oram, Rourkela Local Displaced Association -32 met the Hon'ble Chairperson on 24.03.2017 in the matter.

8. Whereas Shri Nand Kumar Sai, Hon'ble Chairperson, NCST has fixed up a Sitting in the matter and desired your presence **in person with you in the Commission on 16.05.2017 at 03:00 PM.**
