

Minutes of the Sitting held under the chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Schedule Tribes at Lok Nayak Bhawan, New Delhi, in the case of Sh. Tiken Soren regarding false and forged documents for termination of LPG Distributorship M/s Jharkhand Indane at Giridih, District – Giridih, Category-ST.

- The present matter relates to Jharkhand Indane Distributorship agreement of IOCL was executed with Shri Tiken Soren and Smt. Yashoda Devi, on 12.11.2014. Shri Tiken Soren has entered into an unauthorized partnership with Smt. Kanchan Devi. A complaint from Smt. Kanchan Devi, w/o Sh. Sudhir Kumar was received issues raised in complaint were Shri Tiken Soren, partner of M/s Jharkhand Indane has taken financial assistance from her and he made her Partner in the distributorship mentioning her as his wife. Though Smt. Nuni Murmu is the lawfully wedded wife of Sh. Tiken Soren. Shri Soren is a ST who claims he is an illiterate and cannot read and write.
- Reply received from IOCL on 09/03/2022, By the observations from Indian Oil Corporation Ltd. it was established that Sh. Tiken Soren submitted false and forged documents about his wife during his application as well as signing of Agreement in respect of her name and entering into an unauthorized partnership, therefore action has to be taken against the distributorship as per guidelines. Accordingly, show cause notice for termination of the distributorship was served to the partner, advising Sh. Tiken Soren to submit his explanation/ reply within 15 days but based on his request, additional 30 days beyond 15 days was accorded to him. IOCL representative mentioned that during the verification vigilance cell could not trace Voter ID card of Yashoda Devi on Election Commission website, which was not found genuine.
- The commission issued summons to the Mr. Shrekant Madhav Vaidya, President Indian Oil company Ltd. on 04/10/2022. In response to the summons issued by the commission, on behalf of Mr. Shrekant Madhav Vaidya, President, IOCL a

representative Mr. P. Jayaderan, EDC (LPG), IOCL & S. Lakshmi Narayanan, CGM (LPG-Sales), IOCL appeared before the commission for sitting on 14/10/2022.


- During the course of hearing the Commission enquired about the Steps taken for the protection of ST Person ? During the inquiry is the intention observed or asked from accused taking the tribal nature, socio-economic condition of the petitioner.
- In response the IOCL Authorities stated about the vigilance enquiry conducted in the matter whereby legal action has been initiated. The IOCL Authorities also ensured the Commission a copy of the Vigilance report shall be submitted to the Commission. All possible steps shall be taken to protect the rights of the tribals be taken.

**RECOMMENDATIONS: -**

After hearing both the sides the Commission Recommends the followings -

- The commission asked the petitioner to file a complaint in the Police station regarding the forgery and cheating happened with him and send a copy of the same to the commission.
- The petitioner is also asked to submit the original voter id card of Smt. Yashoda Devi alias Smt. Nuni Murmu in Indian Oil Corporation Ltd.
- The Commission asked IOCL to re-inquire and revisit all the angles of the case, observe the intention and submit a report.
- The Commission also asked IOCL, to let the distributorship of Shri Tiken Soren continue till the logical conclusion before the Commission.

The Compliance report with Action taken shall be submitted before the Commission within 30 days.
