

Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, in the case of Shri Padam Singh Bhabhar, r/o Rasukundiya Village, Mhow Tehsil, Indore district, Madhya Pradesh

Date of the Sitting: 02.12.2022

Participants in the Sitting: As per Annexure

Shri. Padam Singh Bhabhar had filed a Complaint on 11/10/2022 to NCST, New Delhi stating that on 01/07/2022 his wife Smt. Ramkanya was burning dried leaves in their agricultural land due to which a dried tree located in their land caught fire. On the same day, Shri. Ravikant Jain, Choral Forest Ranger & other authorities of the Choral Forest Range had come to the incident spot. Without making any kind of enquiry, directly started using abusive words against Shri. Padam Singh Bhabhar's family & the Bhil community, also have put false allegations that he had encroached the forest land and subsequently, the authorities forcefully took him to the Choral Range Office. At the authorities beat him up with sticks, causing an injury near the left eye and on the right hand. Later, they took him to the Primary Healthcare Care Center, Simrol in the pretext of getting medical aid. However, they have sent him back without any treatment. After facing such harassment, Shri. Padam Singh Bhabhar filed a complaint at the Simrol Police Station against Shri. Ravikant Jain and other authorities. Police authorities, till date have not taken any action against the authorities apart from registering FIR. Hence, the Complainant has filed this Complaint before the NCST.

The Commission issued notice to the Principal Secretary, Forest Department, Govt of Madhya Pradesh, District Collector & Commissioner of Police, Indore District, Divisional Forest Officer, Indore District on 18.10.2022 and sought a reply within 03 days of the receipt of the notice.

Pursuant to the notice Shri Rakesh Gupta, Inspector General of Police, Indore Rural Zone via letter dated 21/10/2022 sent a reply stating that the Superintendent of Police (Rural), Indore District investigated the matter and submitted a report that FIR has been filed on 01/07/2022 against the Charol Range authorities in Simrol Police Station under IPC and SC & ST atrocity act also proper treatment was given to Shri. Padam Singh Bhabhar injuries. Further submits that the Complaint has been registered by Ranger, Choral range against Shri. Padam Singh Bhabhar on 01/07/2022 to IGP, Indore Rural Zone stating that the

In this matter, as per direction of Hon'ble Member, Summons was issued to The Commission issued summons to Principal Secretary, Forest Department, Govt of Madhya Pradesh, District Collector & Commissioner, Indore District, Superintendent of Police (Rural Range), Indore and Divisional Forest Officer, Indore District on 18.11.2022 to appear before the commission on 02.12.2022

Shri Manish Singh, District Collector Indore via letter dated 04.11.2022 sent a reply stating that the Sub-divisional officer, Mhow Teshil investigated the matter and submitted that the wife of Complainant Smt. Ramkanya was burning dried leaves in their agricultural land due to which a dried tree located in their land caught fire. On the same day, Shri. Ravikant Jain, Choral Forest Ranger & other authorities of the Choral Forest Range had come to the incident spot. Without making any kind of enquiry, they directly started using abusive words against Shri. Padam Singh Bhabhar's family & the Bhil community, also alleged that the Complainant had encroached the Forest land and without any written orders on the arrest of the Complainant they directly arrested and put complainant inside the cell. The FIR has been filed against the Ranger and other Beat Guards under IPC and SC & ST Atrocity act, It is Confirmed through the witness that the Tractor of the Complainant and the Shri Ramesh Bharood tractor was seized also no written order was given on the seizure, it was found that the forest department had loaded the wood on the tractor and clicked the photo of the same, but the investigation is under process & no supporting evidence has got till date.

In the sitting, Secretary, Forest Department, Govt of Madhya Pradesh stated that the Complainant had encroached the forest land and ploughed the land using his tractor also there are many previous complaints on both the complainant and his son, so on illegal encroachment the authorities have followed their duty by investigating the matter, they have neither assaulted nor hit the Complainant, he has not got any injuries. The residents of Raskundiya village have given testimony against the Complainant that he had encroached the land also the Mhow range is forest area there is regular encroachment by the villagers so to stop the illegal encroachment the authorities have taken necessary steps on this fact the

authorities have not done anything outside the law, to escape from the incident Complainant has filed false compliant against choral range authorities.

The Petitioner submitted that his wife was burning dried leaves in their agricultural land due to which a dried tree located in their land caught fire to inquire about the incident, the authorities had come to the spot even before making any inquiry, authorities started using abusive language against the family & the Bhil community, also put false allegations that he encroached the forest land. Thereafter, forcefully took to Range Office then locked up in cell also beat up with sticks which caused serious injuries near the left eye and on the right-hand wrist. After inflicting such injuries forest officials took him to Primary Healthcare Centre, Simrol. Instead of getting the injuries, authorities coerced him to sign on a few papers without giving any information later left him at the Primary Healthcare Centre, then with his son took him to Simrol Police Station to lodge complainant but the Station Officer suggested to take him to the hospital first for treatment so they went to nearby govt hospital, the Doctor on seeing the conditions did first-aid and recommend to get X-ray & further treatment in M.Y. Indore Hospital. After getting treatment went back to Police Station to lodge a complaint. The police filed FIR, on the next day Complainant & his son went to M.Y Hospital, Indore for a follow-up check-up. Doctor examined the injuries and said that the no injury on the wrist. However, after the check-up the injuries was in same condition and there was not recovery. So they went to a private hospital and got the treatment which costed around fifteen thousand, that after few hours of the incident again Forest authorities went back to the village and seized his tractor along with his neighbour newly purchased Tractor, where it was parked near the house. Later tried to explain that they had neither encroached nor ploughed the forest land and that the allegations made by the authorities was not true. They further made several requests, but till date the authorities have not resolved the issue. Instead, the Ranger said that the seized tractor will be released only would take back the complaint registered.

The Commission has pointed that through the commission field visit dated 12.10.2022 it is found that the on considering the Submissions of the Complainant, Other residents and on verifying the records submitted, the Complainant has not encroached any land of the forest. The investigation team verified the documents and the boundaries through visiting the spot also the Complainant had showed the photos of the injuries Complainant suffered due to the beatings of the forest authorities. The photos are attached to Commission investigation report(Copy of the detailed Commission investigation report with the recommendation has been attached as annexure)

- Through Secretary, Forest Department, Govt of Madhya Pradesh the higher authority team shall be constituted to re-investigate the matter and to submit interim report within 15days and complete report within 30 days.
- Superintendent of police, rural Zone Indore shall to enquire on the inaction against the authorities responsible and also ensure that appropriate legal action taken against them at the earliest and send report within 15 days.
- District Collector to ensure that the Complaint shall be compensated for the Hospital expenses to the injuries inflicted by the authorities.
- District Forest Officer shall ensure that the Tractor of the Shri. Padam Singh Bhabor (Complainant) and the Shri Ramesh Bharood tractor to be released at the earliest.
- District Administration to co-ordinate among themselves and ensure proper compensation for the loss of income and livelihood caused to the Complainant also ensure that the appropriate action taken against the Ranger & Beat guards.

If the Report is not Found to be satisfactory, a team from the NCST will make a field visit.

# FIELD VISIT REPORT ON SHRI PADAM SINGH BHABHAR, RASUKUNDIYA VILLAGE, MHOW TEHSIL, INDORE DISTRICT, MADHYA PRADESH

(NCST/ATY-704/MP/14/2022-APCR)

The National Commission for Scheduled Tribes (NCST), a Constitutional body under Article 338A of the Constitution of India, constituted a 2-Member Investigation team to probe into the facts by conducting an on-site investigation relating to Shri. Padam Singh Bhabhar, r/o Rasukundiya Village, Mhow Tehsil, Indore district, Madhya Pradesh Complaint filed on 11/10/2022 to NCST, New Delhi.

## Summary of the Article:

Shri. Padam Singh Bhabhar had filed a Complaint on 11/10/2022 to NCST, New Delhi stating thaton 01/07/2022 his wife Smt. Ramkanya was burning dried leaves in their agricultural land due to which adriedtree located in their land caught fire. On the same day, Shri. Ravikant Jain, Choral Forest Ranger& other authorities of the Choral Forest Range had come to the incident spot. Without making any kind of enquiry, about the incident they directly started using abusive words against Shri. Padam Singh Bhabhar's family & the Bhil community. Apart from this, they also started putting false allegations that he had encroached the forest land and subsequently, the authorities forcefully took him to the Choral Range Office. At the Range Office, Shri. Ravikant Jain and other authorities beat him up with sticks, causing an injury near the left eye and on the right hand. Later, they took him to the Primary Healthcare Care Center, Simrol in the pretext of getting medical aid. However, they have sent him back without any treatment. After facing such harassment, Shri. Padam Singh Bhabhar filed a complaint at the Simrol Police Station against Shri. Ravikant Jain and other authorities. Police authorities, till date have not taken any action against the authorities apart from registering FIR. Hence, the Complaint has filed this Complaint before the NCST.

#### In this case, the Commission sent the notice on 18/10/2022 to:

- 1. Principal Secretary, Forest Department, Govt of Madhya Pradesh
- 2. District Collector, Indore District
- 3. Commissioner of Police, Indore District
- 4. Divisional Forest Officer, Indore District

To submit action taken report within 03 days. NCST Investigation Team on 13.11.2022, consisting of Shri Govardhan Munde, Senior Investigator and Shri. Avinash, Legal Consultant visited Rasukundiya Village. Mhow Tehsil, Indore District, Madhya Pradesh to conduct investigation. The detailed report of the investigation ismentioned below:

# Details of the Meeting held in Raskundiya Village:

On 13.11.2022, the NCST Investigation Team convened a meeting at the Complaint's residence, Rasukundiya Village, Mhow Tehsil, Indore District, Madhya Pradesh. The Complaint along with other residents of the village attended the meeting to give their testimonies with respect to the Complaint. The list of the attendees is attached to this Report and is marked as Annexure 01.



#### The testimonies of the Complaint and the residents of the village are mentioned below:

- Shri Padam Singh Bhabor (hereinafter referred to as "Complaint") submitted that on 01/07/2022 all the villagers, including himself had gathered near Mataji Temple for a meeting regarding the Ashadha Puja program. Duringthe sametime his wife Smt. Ramkanya Bhabor was cleaning their agricultural land. She had collected all the dry leaves and was buring them at their agricultural land.
- 2. While the dried leaves were burning, a driedtree on their agricultural land caught fire. To inquire about the incident, (1) Shri. Ravikant Jain, Choral Forest Ranger (2) Shri. Nakedhar Jagdish Mandloi, Beat Guard (3) Shri. Nakadar Ramesh Katare, Beat Guardand (4) Shri. Chandrakant Chouhan, Beat Guardwent to the spot of incident. On reaching the spot of incident,

even before making any inquiry, all of said authorities started using abusive language against the Complaint's family &the Bhil community in the presence of the villagers. Apart from this, the said authorities have put false allegations against the Complaint and his family that they have encreached the forest land.

- 3. The Complaint repeatedly requested the said authorities' to not use such abusive words and also tried to explain the whole incident. However, thesaid authorities didn't listen to any of the requests. Instead, Shri. Ravikant Jain, Choral Forest Ranger warned the Complaint that he will teach him lesson in Choral Range Office and directed Beat Guards, Shri. Nakedar Jagdish Mandloi and Shri. Chandrakant Chouhan to take him to the Choral Range Office. Thereafter, the Complaint was forcefully carried on bike to Choral Range Office. The said authority's then locked Complaint up in cell.
- 4. In the cell, Shri Ravikant Jain, Range Officer and Shri. Nakedhar Jagdish Mandloi beat the Complaint up with sticks which caused serious injuries near the left eye and on the right-hand wrist. The Complaint was then beaten by Shri. Nakedhar Ramesh Katara and Shri. Chandrakanth Chouhan by fist and kick blows, which caused injuries on both legs and body. Photos of the injuries suffered by the Complaint at the hands of the said authorities is attached to this Report and is marked as Annexure 02. After inflicting such injuries to the Complaint, Deputy Ranger & Shri. Jagdish Mandloi, Beat Guard took him to Primary Healthcare Centre, Simrol. Instead of getting the Complaint treated for the injuries inflicted by them, they said authorities coerced him to sign on a few papers without giving any information to the Complaint about the content written on them. The said authorities neither communicated nor informed the Complaint of the content written on the paper. After getting the papers signed by the Complaint, the said authorities left him at the Primary Healthcare Centre, Simrol and went away.
- 5. Shri, Dharmendra Bhabor, son of the Complaint submitted that during the incident he was present and thatall the facts submitted by his father to investigation team were true. He further stated that Beat Guards Shri. Nakedar Jagdish Mandloi & Chandrakant Chouhan forcefully carried the Complaint on their bike and took him to the office. Being horrified by the way the Complaint was forcefully carried away, Shri. Dharmendra Bhabor along with the villagers reached the office and requested for the Complaint's release. The authorities did not pay any heed to the request of Shri. Dharmendra Bhabor and the villagers. The authorities did not even allow them inside the office. Shri. Dharmendra Bhabor and the villagers stood outside the entire day. In the evening they saw authorities taking the Complaint in jeep. Shri. Dharmendra Bhabor and the villagers followed them on bike and reached the Primary Healthcare Centre, Simrol. It was only when they reached the Primary Healthcare Centre that they were able to meet the Complaint. But they

were shocked to see the critical condition of the Complaint. The Complaint had a blood clot near hisright eye & it was swollen; his clothes were covered with blood. The Deputy Ranger and Beat Guard were with the Complaint. Thedoctor did not treat the injuries of the Complaint. Later, the authorities present with the Complaint made him sign on a few papers without informing about the content. Later, when the Complaint checked, he got to know that the authorities had made him sign papers stating that he got hospitalized and took proper treatments. Since the Complaint wasn't treated, he questioned the doctor and the authorities on the illegal practice, but did not getany response. After this, the authorities were taking the Complaint back to the Range Office. Shri. Dharmendra Bhabor and the villagers requested the authorities to leave the Complaint at the Primary Healthcare Centre, Simrol so that they could get him the necessary treatment. Initially the authorities denied their request. It was only after much persuasion that the authorities agreed. Shri. Dharmendra Bhabor and the villagers first they took Complaint to Simrol Police Station to lodge Complaint against forest authorities. But the Station Officer suggested to take him to the hospital first for treatment so they went to Mhow Government Hospital for treatment. At Mhow Government Hospital, the Doctor on seeing the conditions did first-aidand recommends that the Complaint get X-ray & further treatment in M.Y Indore Hospital. After getting treatment for the Complaint, on the same day, Shri. Dharmendra Bhabor along with the villagers went back to Simrol Police Station to lodge a complaint. The police filed FIR against the all four authorities under IPC and SC and ST (Prevention of Atrocities) Act. FIR is attached this Reportand is marked as Annexure 03.On the next day Complaint& his son went to M.Y Hospital, Indore for a follow-up check-up. Doctor examined the injuries and said that the Complaint sustained no injury on the wrist and that Complaint's right eye was swollen & clotted. The doctor further mentioned that a report on the injuries sustained by the Complaint would be sent to Simrol Police Station for further enquiry. However, after the check-up the Complaint's injuries to and near the eye was in same condition and there was not recovery. So they went to a private hospital and got the treatment which costed around fifteen thousand. And 20 days later it got cured slowly.

6. Shri. Ramesh Bharood, resident of Raskundiya Village said that after few hours of the incident again Forest Ranger Ravikant Jain & other authorities went back to the village and seized his newly purchased Holland Tractor, (not even got name plate) where it was parked near the house along with the Complaint's. tractor MP 45 AB – 5355 took them to Charol Range office. When the said authorities seized the vehicles, both (himself and the Complaint) were not at the spot. As soon as they became aware of the incident from villagers, Shri. Ramesh Bharood and the Complaint went to station to enquire on the seizure. To this, the authorities responded by alleging that Shri. Ramesh Bharood and the Complaint had encroached and ploughed the forest land with tractor. Shri. Ramesh Bharood and the Complaint tried to explain that they had neither encroached nor ploughed the forest land and that the allegations made by the authorities was not

true. Shri. Ramesh Bharood further explained to the authorities that the tractors were a major income source for the family and that they had purchased that tractor on loan and that it would become very difficult to payback the debt without any source of income. They further made several requests before the Choral Range &Sub-Divisional Office, but till date the authorities have not resolved the issue. Instead, the Ranger said that the seized tractor will be released only if Shri. Ramesh Bharood and the Complaint would take back the complaint registered with Simrol Police Station.

# Details of the Verification held in Complaint Farmland:



(Investigation Team visited Complaint Shri Padam Singh Bhabor farmland with other residents of the Raskundiya village to verify the whether the Complaint has encroached forestland)

During the verification by investigation team, the Complaint showed the boundaries of his farmland. He informed that their was his ancestral property, which they have been cultivating from generations. Thetitle of the land was in the name of his father and father's eldersister namedShri. Aharam Jhangiya Bhabor and Shri. Kuthal Bhai respectively. The farmland was around 9-hectare. Copy of the land record is attached in this Report and is marked as Annexure 04.1tstheir only source of income. The Complaint further submitted that this land is adjacent to forest land and that there is clear bifurcation in his agriculture land the forest land. The Complaint further submitted that the forest department have clearly marked the boundaries and have also have fenced it and that the Complaint never encroached even an inch of the forest land and that the allegations made by the forest authorities were wrong. The Complaint submitted that the allegations made against him were false. The Complaint further submitted that on 18 September, 2022 the water pump which was in his land was taken away without any kind of intimation from the Forest Authorities. The Complaint informed that he had filed a complaint with the Ranger and

Sub-Divisional Office, but there is no action taken by the authorities till date. The Complaint submitted that the authorities were causing unnecessarytrouble and have demanded the Complaint to take back his Complaint registered in police station. The authorities have further threatened the Complaint that he will face severe problems if he does not take back the Complaint. The Complaint further submitted that he had been paying taxes for a long time, however, from the past 7-8 years, the Government has not been taking any taxes. He further submitted that the Sub-Divisional authorities have informed him that his land is classified as "vangram" and that they have clarification between vangram and the revenue village. They were in confusion and were not getting any facilities from the government. Many Government Schemes were not even made available to them since their land was classified as vangram. The seizure of tractor and hand-pump by the authorities is a torture inflicted on him and his family and it has been affecting their livelihood and has caused them hardship.

The villagers present during the spot verification said that the Complaint had not encroached any land of the forest and that he was cultivating in his own land. During the submissions being made by the villagers, Patwari was present. The Patwari confirmed that the land belonged the Complaint and further that it was recorded in revenue records and that the Complaint had not encroached land of the forest.

The villagers further submitted that since the administration has now declared this village from revenue to Van Gram, the entire village is facing problems since they are not able to avail any schemes or benefits of the government.

Authorities Presence during the investigation: No authorities from the District and TehsilWere Present throughout the Investigation

#### Observations of the Investigation team:

On considering the Submissions of the Complaint, Other residents and on verifying the records submitted, the Complaint has not encroached any land of the forest. The investigation team verified the documents and the boundaries through visiting the spot.

The Complaint had showed the photos of the injuries Complaint suffered due to the beatings of the forest authorities. The photos are attached to this Report and is marked as Annexure 05

# Recommendations of the Investigation team:

- Commissioner of police, rural Zone Indore should conduct Proper investigation in this matter, further Charge sheet against the authorities should be initiated against the Ranger & Beat guard.
- Hospital expenses of the Complainant should be compensated for the treatment of the injuries inflicted by the authorities.
- The Tractor of the Shri. Padam Singh Bhabor (Complainant) and the Shri Ramesh Bharood tractor to be released at the earliest.
- 4. District Administration must co-ordinate among concerned authorities and ensure proper compensation for the loss of income and livelihood caused to the Complainant also ensure that the appropriate action taken against the Ranger & Beat guards.




