

A representation dated 12/02/2017 was received from Ms. Kiranbhai Chhotubhai Basava, R/o 27 - Devasis Society, Mukkam Post - Vadiya, Rajpipla, District-Narmada, Gujarat regarding compassionate appointment in the Panchayat Department.

The matter was taken up with the Principal Secretary, Panchayat Rural Housing and Rural Development Department, Govt. of Gujarat for taking necessary action vide this Commission's letter dated 14/03/2017. None reply was received from the PRHRD Department, therefore, Shri H.C. Vasava, Hon'ble Member, NCST has fixed a sitting on 07/06/2017 at 12:00 Noon in the matter. Accordingly, a sitting notice has been issued.

Discussion:

Shri S. S. Parekh, Deputy Secretary, PRHRD Department, Govt. of Gujarat appeared before the Commission with an exemption letter of Shri Raj Gopal, Principal Secretary, PRHRD Department, Govt. of Gujarat. The petitioner was also appeared in the sitting. Matter was discussed in details. Hon'ble Member (HCV) asked the Deputy Secretary, PRHRD Department about action taken on the issue. The Deputy Secretary submitted to the Commission that Shri Kiranbhai Chhotubhai Basava has not been found eligible for compassionate appointment in the Department as per prescribed criteria. The Commission advised the PRHRD Department that the case of Shri Kiranbhai Chhotubhai Basava for compassionate appointment may be considered as a special case taking into consideration all the aspects of the case.
