

Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, in the matter of Shri S.N. Gond, who sent the representation on behalf of Smt. Nisha whose husband was murdered and Failure and Inaction of the police Officials.

Date of the Sitting: 17.02.2023

Officials present in the Sitting: As per the Annexure

In the present matter, Shri S.N. Gond, the petitioner vide a representation to the Commission stated that Smt. Nisha's husband was murdered by some Anti-Socials. They assaulted him and brutally killed Nisha's husband. When he was taken to the hospital, he was declared dead. The FIR was lodged by Delhi Police on 26.08.2022 only against two ruffians but no further action was taken by them.

Taking serious view of the issue, the Commission issued Notice to the Commissioner of Police, Delhi on 21.10.2022.


Despite issuance of Notice, no reply was submitted by the Authority. The Commission, issued Summons to the Commissioner of Police, Delhi seeking his personal appearance in the Sitting held on 17.02.2023. The Deputy Commissioner, South District, Delhi appeared before the Commission on behalf of the Commissioner.

The Commission expressed serious displeasure on the non-submission of reply by the concerned authorities. Further, the Commission sought to know the details of the action taken on the issue.

Responding to the queries of the Commission, the Deputy Commissioner, South District, Delhi stated that the investigation has already been completed and the case has been proceeded in the court. With regard to the compensation, Delhi Legal Services Authority has been approached and further process is going on.

The Commission noted the statements and reports produced by the Deputy Commissioner, South District, Delhi and recommended the Deputy Commissioner, South District, Delhi to submit the status report of the case as on date.





The Deputy Commissioner, South District, Delhi to submit the payment proof of the Compensation paid to the victim in the present case.
