Subject:- Representation dated 17.08.2016 received from Shri J. R. Meena, Deputy Director, Ministry of Statistics and Programme Implementation, NSSO(FOD), Hawa Sadak, Jaipur regarding promotion of Shri J.R. Meena to the Post of Junior Time Scale (JTS) of Indian Statistical Service (ISS) against the backlog vacancies year 1997-98 for ST category.
