1 Shri Albert Baa (Group Capt., DRDO Bhawan, Rajaji Marg, New Delhi), father of the candidate vide his representation dated 14.08.2017 has requested for justice regarding admission of Ms. Mansi Josephina Baa to M.Phil program 2017 in School of Arts and Aesthetics at JNU under ST reserved category as per provisions in Central Educational Institutions (Reservation in Admission) Act 2006 and 2007 and University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D degree) Regulation 2016.

2 The Commission decided to discuss the issue with the Vice Chancellor and Director (Admission), JNU to resolve the matter. Accordingly, NCST fixed a sitting for 22.08.2017 and issued a notice vide letter No.AB/4/2017/MHRD2/DEOTH/RU.III dated 18.8.2017 to all concerned.

3 Hon'ble Vice Chairperson, NCST, held a sitting with Vice Chancellor, JNU and Director (Admissions) of JNU on 22.08.2017 regarding admission of Ms. Mansi Josephina Baa in M.Phil program in the School of Arts and Aesthetic against quota for STs.

4 The Vice Chancellor, Jawaharlal Nehru University (JNU) informed the Commission that in the matter of admission and reservation, JNU follows the guidelines of University Grants Commission(UGC) and the instructions of the Ministry of Human Resource Development (Department of Higher Education). During the current year, the UGC has restricted the number of M.Phil/Ph.D students that can be taken up by one faculty. This has reduced the number of seats in the current year. The Director (Admissions), JNU, informed that Ms. Mansi Josephila Baa appeared in the JNUEE under the ST category for admission to M.Phil course in Visual Studies in the School of Arts and Aesthetics. She, however, did not qualify as there were 5 seats in the course in Visual studies. As per Roster Points the distribution of these 5 seats is as under:

Unreserved (UR)	-	3
Scheduled Castes (SC)	-	1
Scheduled Tribes (ST)	-	0
Physically Handicapped (PH)	-	0
Other Backward Classes (OBC)	-	1

5 Joint Secretary (NCST) wanted to know why the University is not following 100 Point Roster in a cumulative manner instead of considering afresh for each year. The Vice Chancellor and Director (Admission) mentioned that in case an advisory is issued by UGC or Ministry of Human Resource Development, Deptt. Of Higher Education or NCST, they will place the matter before the appropriate body of the JNU for admissions.

6 It was decided that a meeting may be convened by the Commission with UGC and Department of Higher Education along with Director (Admissions), JNU to take a holistic view in the matter of application of roster points for admission in various courses.
