**Discussion:**

Shri Sunil Kumar Srivastav, Special Secretary appeared before the Commission on behalf of the Principal Secretary, Social Welfare Department, Govt. of Uttar Pradesh on 13/10/2017. Shri R. K. Aggarwal, CED, BBD NITM, Lucknow, Uttar Pradesh also present on the day of sitting. Shri Chandan Kumar, petitioner was also presented in the sitting. The matter was discussed in details.

Hon'ble Member asked the petitioner about his grievances. The petitioner apprised that the BBD NITM college is not providing the degree certificate (B. Tech.) as the promised scholarship has not been released by the Social Welfare Department, Govt. of Uttar Pradesh to the College.

During the sitting the Special Secretary, SWD, Govt. of Uttar Pradesh submitted to the Commission that scholarship of Shri Chandan Kumar will be released to the College within 15 days. Accordingly, the CED, BBD NITM assured to the Commission that B. Tech degree of Shri Chandan Kumar will be provided to him as soon as the fees due from him is received.
