Minutes of sitting held in the Commission on 02.11.2017 at 4.00 P.M. under the Chairmanship of Shri Hari Krishan Damor, Hon'ble Member, NCST in the case of Shri Raju Doley, R/o C-904, Happy Home Apartments, Plot No.12A, Sector-7, Dwarka, New Delhi-110075 regarding request for free and fare enquiry of atrocity and inaction of Gogamukh Police Station, District-Dhemaji, Assam with reference to FIR against Shri Ghana Doley.

A representation dated 24.07.2017 received from Shri Raju Doley, R/o C-904, Happy Home Apartments, Plot No.12A, Sector-7, Dwarka, New Delhi-110075 regarding request for free and fare enquiry of atrocity and inaction of Gogamukh Police Station, District-Dhemaji, Assam with reference to FIR against Shri Ghana Doley.

2. The matter was taken up with the Superintendent of Police, District Dhemaji, Assam-787057 vide this Commission's letter of even no. dated 16.09.2015. Despite reminders dated 23.12.2015, 09.05.2017 and 04.08.2017. No reply/comments were received in the Commission from the Superintendent of Police, District-Dhemaji, Assam. Shri Hari Krishan Damor, Hon'ble Member, NCST has fixed a sitting with Superintendent of Police, District-Dhemaji, Assam for discuss the matter on 02.11.2017 at 4.00 P.M. in person.

Discussion:-

Shri Hari Krishan Damor, Hon'ble Member, NCST asked the petitioner to submit his grievances, in response to this, Shri Raju Doley has stated that his uncle (Shri Ghana Doley) was arrested by Shri Kuldeep Gogoi, S.I. of Assam Police in a fake case and took him to the Police Station and took his signature forcefully on a deed agreement to pay Rs.75,000/- to Shri Pradip Gogoi. Shri Pradeep Gogoi was well known to him. Shri Ghana Doley was charge-sheeted in the above mentioned case, and a case was filed in the Court of Law and he was detained for three month in the police custody/ judicial custody. The reputation of Shri Ghana Doley (uncle of the petitioner) has been smashed in the society due to false allegations. He again reiterated that this type of incidents should not occur with other persons in future. So he is perusing the matter for the sake of others also. The Hon'ble Member (HKD) directed the Assistant Superintendent of Police, District-Dhemaji, Assam to hold a fact finding detailed enquiry against erring Police Official of Assam Police. The Hon'ble Member (HKD) asked the Additional S.P.(HQ), District-Dhemaji, Assam to give their views in the matter, in this regard, Shri Kamal Kumar Gupta, Additional S.P.(HQ) of Assam Police has requested to grant them three month's time for detailed enquiry report because there is law and order problem in Assam. The Hon'ble Member, NCST has agreed with the request of Shri Kamal Kumar, Additional S.P.(HQ) of Assam Police and
