National Commission for Scheduled Tribes, a Constitutional body set up under Article 338A of the Constitution is, inter-alia, entrusted with duties to inquire into specific complaints with respect to the deprivation of rights and safeguards of Scheduled Tribes and has been given powers of civil court to deal with the complaints. You are, therefore, expected to send the requisite information within the stipulated time.


