OFFICE MEMORANDUM

It has been decided to organize "Awareness Camps" in various states for creating awareness among the Scheduled Tribes about role and functions of National Commission for Scheduled Tribes. Following activities may be undertaken during the awareness camps: -

- (i) Visiting 2 or 3 Districts of States and Organizing Awareness Camps of NCST
- (ii) Preparation and Displaying of Posters/Banners about the role, functions and powers of NCST.
- (iii) Creating Awareness about NCST and various safeguards for protection, welfare, development and advancement of Scheduled Tribes.
- (iv) Interaction with Tribal Delegates/Representatives and Guiding them in obtaining the help from NCST.
- (v) Printing and Distribution of Pamphlets in Hindi and English languages and if possible, in local/regional languages.
- 2. The expenditure involved in traveling, boarding/lodging and all the activities related to organizing awareness camp can be booked in the 'Advertising and Publicity' budget head and officers of NCST Hqrs. and Regional Offices may organize the camps as per tentative schedule given below:-
