OFFICE ORDER

In pursuance of Deptt. of P&AR UO No. 13/2/79-CS II dated 05.06.1979 Hon'ble Chairperson of National Commission for Scheduled Tribes (NCST) vide note dated 18.03.2021 has appointed Shri Abhinav Prakash as Assistant Private Secretary (APS) on Co-terminus basis w.e.f. 25.02.2021 (FN).

2. Shri Abhinav Prakash is appointed as Assistant Private Secretary (APS) to the Hon'ble Chairperson, NCST in the Pay Matrix level 7, stage 1 under 7th CPC with effect from 25.02.2021(FN). His basic pay will be Rs.44900 + allowances. His appointment is subject to the condition that in the event of any adverse report on character verification or medical test, his services shall be terminated.

The appointment of Shri Abhinav Prakash as Assistant Private Secretary (APS) shall be on co-terminus basis with the tenure of Hon'ble Chairperson, National Commission for Scheduled Tribes and his service shall be terminated at any time at the pleasure of the Hon'ble Chairperson, National Commission for Scheduled Tribes, New Delhi, without assigning any reason therefore.

4. The appointee shall have no claim whatsoever, to regular appointment in the Government of India by virtue of this appointment, nor for any other compensation not specified is there any separate terms of appointment.

5. As per OM No. 18011/2(S)/2016-Estt.(B)(i) dated 29th June, 2016 of DoPT, appointment of Shri Abhinav Prakash to the post of Assistant Private Secretary (APS) is provisional as the verification of Character & Antecedents and Medical Examination are pending.
