At the outset, Secretary, NCST requested Ms. H.T. Hliri, Tech. Director, NIC to read out the Terms of Reference (TOR) for the STGRAMS. The Tech. Director, read out the TOR and enquired from the Vendors if they understood the TOR, for which they replied in affirmative.

After a detailed discussion on the subject, the following features were added to the TOR, already circulated among the vendors:

- i) Dashboard for general public should be provided in the application.
- Role based Dashboard should be provided.
- iii) Users for Members/Departments/CS/State Secretaries/DMs/DCs/DGPs/SPs may be provided in the application.
- iv) Provision to integrate with e-office may be provided
- Provision for integrating existing FTS may be provided.
- vi) The Portal/Application should be Bi-lingual (English/Hindi) for the Application as well as Mobile Apps
- vii) Mobile Apps may be Android and IOS (Iphone OS) based.
- viii) E-mail and SMS alert to all concerned parties for any notices.

Finally, it was also decided that the selection criteria would be Quality Cost Based System (QCBS) on 75:25 basis for Technical bid and Finance bid.
