Sub: Relieving of Shri Sudhir Shrawan Atram, PS to Member (MCI), NCST, New Delhi appointed on Co-Terminus Basis.

Shri Sudhir Shrawan Atram, Special Auditor Grade-II in Office of Divisional Joint Registrar, Co-Operative Society (Audit) Nagpur Division, 8th Floor, B- 'Wing', Administrative Building No-2, Civil Lines Nagpur-440001 was working on Co-Terminus basis as PS in the office of the Hon'ble Member (MCI), NCST, New Delhi w.e.f. 03.08.2017 (FN).

- 2. Deputy Secretary, Government of Maharashtra, Co-Operation, Marketing and Textile Department, Mantralaya, Mumbai-400032 vide his letter dated 01.08.2017 placed his services at the disposal of the National Commission for Scheduled Tribes on Deputation basis for appointment as Private Secretary to Hon'ble Member (MCI), NCST, New Delhi on Co-Terminus basis. Shri Sudhir Shrawan Atram joined as Private Secretary to Hon'ble Member (MCI), NCST, New Delhi w.e.f. 03.08.2017 (FN).
- 3. The term of appointment of Smt. Maya Chintamn Ivnate as Member, NCST has expired on 27.03.2020. Accordingly, being a Co-Terminus appointment, the services of Shri Sudhir Shrawan Atram as PS to Member have ended on 27.03.2020 (AN).
- 4 Shri Sudhir Shrawan Atram, PS has submitted an application dated 27.03.2020 to Deputy Secretary, NCST requesting for issuance of Salary and retention in NCST due to COVID-19 lockdown. As he has not submitted NOC and No Dues Certificate, Salary for the month of March, 2020 cannot be drawn. As his appointment was on Co-Terminus basis, he cannot be further retained in NCST. However, he may be sanctioned leave due and admissible under the rules if applied for.
