2.1 In pursuance to the discussion held in 85th meeting of Commission, Commission had sent the following comments on the Maharashtra Protection of People from Social Boycott (Prevention, Prohibition and Redressal) Bill, 2016:-

"Commission advised that cognizance of Customary Laws of Tribal/relevant Act etc are need to be taken into account so as to ensure that cases of STs are dealt with by giving due consideration of their Customary Laws/relevant Laws/Acts etc. and also officers appointed for dealing such cases need to be sensitized"

2.2 In response, Ministry of Home Affairs, vide O. M No. 17/35/2016-Judl & PP dated 29.12.2016 forwarded State Government of Maharashtra comments on the above comments of the Commission that "the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 (33 of 1989) is a special law applicable only for the Offences against Scheduled Castes and Scheduled Tribes




Communities. However, the proposed State law will be applicable to all the communities in the State. It is also pointed out that as provided in clause 18 of the Bill, the proposed State law is in addition to and not in derogation of the provisions of any other law for the time being in force. Therefore, if offences are registered under both laws, then the higher punishments for the offence will be applicable. Therefore, it is not necessary to amend the Bill". It has also been informed that "The Government will consider after review of the implementation of the proposed Act. If after review it is felt necessary appropriate amendment in the Act will be carried out".

2.3 The matter was extensively discussed and Commission decided to agree to support the Maharashtra Protection of People from Social Boycott (Prevention, Prohibition and Redressal) Bill, 2016.

- 3.1 Ministry of Tribal Affairs, vide letter No. 19012/01/2016-C&LM-II (Pt) dated 2.1.2017 sent a copy of C.O 268 the Constitution (Puducherry) Scheduled Tribes Order,2016 (in bilingual) published in the Gazette of India on 22.12.2016 regarding scheduling "Irular (including Villi and Vettaikaran)" as Scheduled Tribe in the Union Territory of Puducherry.
- 3.2 The Constitution (Puducherry) Scheduled Tribes Order,2016 was placed before the Commission. Commission desired to circulate it in NCST HQs and its Regional Offices.

- 4.1 In pursuance to the decision taken in the 92nd meeting of the Commission held on 9.11.2016, Director, Regional Office, NCST, Bhopal visited the spot and submitted a report on the incident of Tribal Ashram Shala, Village-Pala, Tehsil-Kham Gaon, District-Buldhana and victims Village-Hal Kheda, Tehsil-Muktai Nagar, District-Jalgaon (Maharashtra).
- 4.2 On perusal of the report, Commission desired to send the Incident Report to the State Government of Maharashtra for necessary action and to ask the further progress of the case in respect of precautionary, preventive and punitive action taken under Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and other action to redress the situation and to prevent such incident in the future.
