Since, the Commission already gave its recommendations to the Ministry of Tribal Affairs for inclusion of the communities mentioned in Cabinet note, in the Scheduled Tribes list of State Governments as indicated in the Draft Note for Cabinet sent by the Ministry of Tribal Affairs, vide their O.M. No. 12026/91/2016-C&LM-I dated 01/02/2016, the Commission agreed and recommended the draft Cabinet Note. The Commission further stated that matter may be taken up with Ministry of Tribal Affairs to take necessary action for inclusion of Scheduled Tribes Communities in the list of STs in the lists of the State Governments for which recommendations of the Commission have already been conveyed.
