Ministry of Tribal Affairs, vide letter No. 19020/04/2015/C&LM-II dated 29.9.15, forwarded a Draft Cabinet Note of Ministry of Overseas Indian Affairs I. D. Note No. OI-11012/133/2012-EP-I dated 21.9.15, on Memorandum of Understanding to be signed by Ministry of Overseas Indian Affairs with Government of Hashemite Kingdom of Jordan, in the field of manpower. NCST has been requested to convey concurrence to proposal contained in Draft Cabinet Note.

2. The Draft Cabinet Note was discussed in the Commission. Commission decided to convey concurrence to the proposal with advice to incorporate special provisions for tribal labourers' protection. Commission further opined that similar kind of MOUs may also be signed with other Nations where-in Indian labourers (skilled and unskilled) are going for work, if not yet done.
