Sir,

I am directed to refer to the captioned subject and clarifications desired by NCST relating to appointment as PS/APS/PA with Chairperson, Vice-Chairpersons, Members of NCST. The matter has been examined in consultation with Department of Personnel and Training. It is advised that all the appointments in the personal staff of functionaries of NCST may be made on co-terminus basis as in the case of appointments in the personal section of Ministers and Rules/Regulations/instructions issued by DoPT from time to time in this regard may be complied with.

2. As regards the leave encashment, OTA, CEA, LTC etc., it has been clarified by DoPT that the instructions on the pay and allowances admissible for the staff engaged on co-terminus basis in the personal section of Ministers, is applicable for the persons appointed as PS/APS/PA with Chairperson, Vice-Chairpersons, Members of NCST during their tenure. NCST, may, therefore, regulate the pay and allowances of such staff in accordance with the guidelines of DoPT issued for the persons engaged on co-terminus basis in the personal section of Ministers.
