- (i) The Commission has also shown concern about delayed (13 days) submission of Note of MoSJ&E by Ministry of Tribal Affairs. Only two days were given for examining and evaluating the Cabinet Note. The Commission asked the Secretariat to write to MoTA, at appropriate level, bringing out the concern of the Commission and advice to forward such Cabinet Note, in time to the Commission, for offering its comments in future.
- (ii) A Report with regard to "encounter of tribals by Andhra Police and Forest officials at Tirupati (A.P.)" submitted to the Commission by the Hon'ble Vice Chairperson after having visited the State of Tamil Nadu and Andhra Pradesh, meeting with concerned authorities and the tribals. The Commission has
