Report and recommendations under Article 338A(5)(e) of the Constitution on the measures to be taken by the Government of Manipur for the effective implementation of constitutional safeguards and other measures for the protection, welfare and socio-economic development of the Scheduled Tribes in Manipur.

No. TP/VC/NCST/2018/54 Dated: 6th - 8th July, 2018

The National Commission for Scheduled Tribes (NCST) is a Constitutional body set up under Article 338A of the Constitution of India to investigate and monitor all matters relating to protection, welfare and socio-economic development of the Scheduled Tribes in the country. As per Constitutional Provision, the Union and every State Government shall consult the Commission on all major policy decisions affecting Scheduled Tribes. The Commission is required to present to the President reports upon working of those safeguards and all such reports are to be laid before each House of the Parliament along with memorandum explaining the action taken or proposed to be taken on the recommendations relating to the Union and the reasons for non-acceptance, if any, of any of such recommendations.

2. In pursuance of the Constitutional mandate, a team from the National Commission for Scheduled Tribes comprising of Miss Anusuiya Uikey, Hon'ble Vice Chairperson, Shri H.K. Damor, Hon'ble Member and Shri P.T. Jameskutty, Deputy Secretary visited Manipur on 6-8 July, 2018 to attended Awareness Orientation programme of Constitutional Rights of Scheduled Tribes in India, at TRAI Conference Hall, held in Imphal, YPA Hall at Churanchandpur on 6th and 7th July, respectively organised by the Manipur Tribal Forum. On 8th July, 2018, the Commission interacted with tribal students' leaders and had meetings with the Scheduled Tribes Commission Manipur state and Secretary Tribal Department, Government of Manipur in Imphal. During the course of the awareness orientation programme, a number of representations were received by the Commission from various tribal organisations. The details of demands/suggestions made by various

tribal organisations raised during the programme and mentioned in the representation are given below.

- v)The Meiteis are demanding to be classified as ST community which is objectionable.
- vi)In the 60 members Manipur Assembly, only 20 MLAs are tribals.
- vii)Autonomous District Councils in tribal areas of Manipur are neither under the Sixth Schedule nor Fifth Schedule of the Indian Constitution.
- viii)Give adequate Constitutional protection to the tribals in Manipur.
- ix)Speed up the on-going political dialogue with tribal SoO groups (UPF and KNO) and
- x)Establish a workable political autonomy, with Bodo Territorial Council as the model, in order to fulfil the age-old political aspirations of the tribals in the State.

i)The tribal students of Manipur University feel neglected, marginalised and insecure

ii)The scholarship give to ST students are meagre. It is requested to increased and extended to all tribals in Manipur.

iii)The 32% reservation norms for ST are not fully implemented. Requested to identify all post vacancies in all departments and make special recruitment drive accordingly. All backlog posts for ST may also be filled up.

iv)The Meitei's claim for ST status is untenable, unrealistic and illogical because of their rich background and social status. Granting them the status of STs will endanger the social equilibrium and they will perpetually subjugate the tribesmen in the hills.



Request for submission of Memorandum related on tribal villages lands encroachment by the Manipur State Forest Department (Cantal) Forest Division), Valley Meitei Societies and individuals at Nongmaiching Hill Range and request for intervention and do the befitting measures to safeguard the Rights of the tribals of Manipur.

3. Meeting with Manipur State Government Scheduled Tribes Commission and Secretary, Tribal Affairs

The Commission met Chairman and other members of the Manipur State Government Scheduled Tribes Commission and discussed the activities being undertaken by the State Commission. The Chairman, State Scheduled Tribes Commission informed that the Commission was set up recently and the Commission is yet to function in full swing. It was also informed that the creation of State Government Commission is widely published in the state of Manipur so that aggrieved ST people can approach the State Commission for redressal of their grievances.

4. Recommendations of the Commission

On perusal of the various representations from various tribal groups, the Commission felt that there are various issues that are affecting the ST people and require immediate attention of state government as well as other authorities. Accordingly, the Commission made following recommendations for immediate action by the authorities concerned.

- i) The Commission observed that in the state of Manipur, there is a 34 percent reservation for the ST people of the Manipur state. It has been brought to the notice of the Commission that there is a huge backlog vacancies to be filled up in various departments in Government of Manipur. The Commission, therefore, recommends that all the backlog vacancies should be filled up through special recruitment drive by the Government of Manipur, immediately.
- ii) Under the guise of Manipur Land Revenue and Land Reforms (MLR & LR) Act, 1960, it has been reported that there are large scale encroachment of tribal land without the consent of tribal people. The tribal lands belonging to tribal people and 'land is life' for the tribal people. The tribal land should not be taken away from tribal people and should be protected. The Commission, therefore, recommends that no land of tribal people should be alienated to non-tribal people.
- University felt neglected and marginalised. They are also reportedly feeling insecure. Therefore, a demand has been made by the various tribal organisations, that there should be a separate University for the entire tribal population of Manipur. The Commission, therefore, advises the Government of Manipur to examine their request for setting up a Hill University for the welfare of tribals of Manipur.

- that these Council are functioning without much power and finance. The tribal areas of Manipur are either in the Fifth Schedule for in the Sixth Schedule. The Commission, therefore, recommends to the state government of Manipur that they should examine the demands of tribal people of Manipur to declare tribal area of Manipur as Sixth Schedule of the Constitution.
- v) Various students organisations of tribals of Manipur have represented to the Commission that there is an urgent need for separate tribal hostels in Manipur University. The Commission, accordingly recommends that the State Government should set up a separate Tribal Hostel for tribal students in the Manipur University.
- Vi) The Commission, while interacting with various tribal organisations of Manipur, received requests from various organisation that the Meites of Manipur are requesting to be included in the list of tribals in the state of Manipur. It was informed that the Meites never have any connection with tribals and they cannot be given the status of tribals. The tribal community requested the Commission to take up the matter with the State Government of Manipur not to proceed with the demand of the Meites to be included in the ST category. Accordingly, the Commission recommends that necessary precaution may be taken in considering any demand or request of Meites for inclusion in the ST category.
- vii) During the course of interaction with various tribal organisation/students organisations, a number of representations were received wherein various demands were raised by the ST organisation. These representations will be forwarded to the state government separately. The Commission



recommends that each of the demands made by the tribal organisations, should be examined and take necessary action to implement those demands for the benefit of the ST people of Manipur state.
