1. MEETING WITH COLLECTOR, CHHOTA UDAIPUR

1.1 Hon'ble Member, Shri Harshadbhai Chunilal Vasava has visited Collector Chhota Udaipur's office on 5th October, 2018 at 15.30 Hrs at Collector's office in which Collector, District Development Officer, Project Administrator, DFO, Assistant Commissioner, Tribal Development and other officials from different Departments were present. Hon'ble Member was welcomed by Resident Additional Collector, thereafter, meeting had started and Project Administrator had briefed about existing work and planning under Gujarat pattern for the benefit of the Scheduled Tribes of the District. Hon'ble Member was briefed by the officers of the Agriculture Department that bore-well, pumpset of submersible pump and tarpaulin distribution to the beneficiaries.



1.2 Hon'ble Member was briefed that under Border Village Rs. 7.88 Lakhs provisions has been made for the basic requirements, under FRA 17557 applications have been received out of which 6667 individual claims have been sanctioned. Checking of files is in progress. Mudhiyari of Bodeli Taluka, Singla, Piplej and Navagam of Chhota Udaipur Taluka have farmers are farming in forest area their claims are under consideration. Certain claims have been sanctioned after verification through satellite from BISAG, few cases don't have other evidence are being considered on the farmers in the forest area. It was suggested by Hon'ble Member that verification of claims be expedited and positive attitude may be helpful for settlement of the claims to the poors.





- 1.3 Project Administrator appraised of the Vocational Training Centre started on PPP model have the student's residence facility for boys and girls. Hon'ble Member inquired that students of this centre are getting placement or not? If they get placement if they leave the job for that certain conditions should be framed so that chance of other student may not affect because of the leaving of the trained student.
- 1.4 Hon'ble member inquired about the procedure for non-duplication of beneficiary in different schemes implemented by govt. collector said that software has been developed in which chances of duplication of beneficiary totally checked. Device have been prepared by GSFC. Member satisfied with the answer and meeting ended with thanks
