

MEETING WITH COMMISSIONER TRIBAL AFFAIRS AT BIRSA MUNDA BHAWAN, GANDHINAGAR, GUJARAT.

1.1 Hon'ble Member Shri Harshadbhai Chunilal Vasava, National Commission for Scheduled Tribes visited the office of Commissioner for Tribal Affairs at Birsa Munda Bhawan, Gandhinagar for certain issues of Ashram Schools Admission and Hostel facilities.

1.2 A representation was received from Samasta Aadhivasi Samaj, Gujarat State vide their letter Dated 11.07.2018 which was mailed to the Commissioner Tribal Affairs for further necessary action. The matter was to verify the false caste certificate produced by some students for admission in Medical Colleges of the State.

1.3 Similarly, admissions in Ashram Schools had some complaints which were discussed with the Tribal Commissioner beside the issues of food in various chhatralaya run by Tribal Department in which rational policy should be initiated by the Commissioner for selection of the caterers agency and the tendering of the same, so that hygienic and nutritive food can be available to the students and some incidences which occurred in few places of State on the issues of food can be avoided. Commissioner Tribal Affairs, Gandhinagar assured that proper care will be taken as per the discussion and suggestions by Hon'ble Member.
