# 1. <u>VISIT OF INDIAN OIL CORPORATION LIMITED (IOCL), MARKETING DIVISION, SOLA, AHMEDABAD</u>

1.1 Hon'ble Member Shri Harshadbhai Vasava visited Indian Oil Corporation Limited (IOCL) Marketing Division office at Sola, Ahmedabad. E.D. Shri S. S. Lamba along with other Senior Officers welcomed Hon'ble Member about 10-11 officials were present in the meeting. They had participated during the deliberation.





1.2 During discussion Hon'ble Member asked whether STs are having petrol Pumps, CNG Pumps, Gas Agencies. Whether in the State any reservation has been for STs, it was briefed that there are number of such agencies allotted to STs in the State. There are 81 outlets of ST category 18 letters of intent (LOI) are pending. 27

Company Owned Company Operated (COCOS) handed over to ST candidates. Even new allocation will also be provided for which process is in vogue to fulfil the reserved quota for such agency back log from 1977 will be calculated and 2.5 times higher applications will be invited for the backlog quota of the reserve category outlets.

- 1.3 Hon'ble Member raised certain points for clarification, he emphasised that since ST are new in such business they may not come forward for such dealership so some training programme for the STs to start business can also be initiated. Indane distributorship about 162 has been under process out of which 36% of SC/ST are under process.
- 1.4 Hon'ble Member inquired about the status of the PNG for domestic users in Narmada District which was announces by the then Hon'ble Chief Minister Shri Narendra Modi.





1.5 Though IOC is not the agency to implement that but it was in the knowledge that in the bidding process by the implementing agency Narmada District has been included. So in near future Narmada District may have the facility of PNG for Domestic users. IOC has three marketing Division in Gujarat i.e. Ahmedabad, Surat and Rajkot.
